Traffic was heavy for several hours in Owingsville last Wednesday afternoon following a multi-vehicle accident on Interstate 64 just west of town.

The accident occurred around 11:30 a.m. and involved two tractor trailers and a passenger vehicle. According to Captain Jamie Collins, East Region Commander for the Kentucky State Police division of Commercial Vehicle Enforcement, a passenger vehicle driven by a woman from Clearfield was traveling eastbound on I-64 when she apparently crossed the median into the westbound lane. Her vehicle struck a tractor trailer, knocking the rear axle off of the trailer, and then struck another tractor trailer on the passenger side. Her vehicle came to rest against the guardrail. The woman was removed from the vehicle by Owingsville Fire Department members, and she was transported to St. Joseph Hospital in Mt. Sterling and later taken to University of Kentucky Medical Center. At press time this week, her condition was unknown.

The two tractor trailer drivers, from Indiana and from Alabama, were uninjured. The Kentucky State Police, Owingsville Police Department, Owingsville Fire Department, Bath County Sheriff's Office, Bath County Emergency Management, and staff from the Kentucky Transportation Cabinet rerouted traffic onto Exits 121 and 123 into Owingsville and onto US 60 to avoid the accident scene. The scene was reopened around 6:30 p.m. The accident remains under investigation by Kentucky State Police and Commercial Vehicle Enforcement.

John Wayne was seated at the end of the table, so the guy took the letter out and said, "Hey, Duke, I was in Rev. Schuller's daughter's room today and she wrote you a letter and wanted me to give it to you. Here it is."

They passed it down to John Wayne and he opened it. They kept on laughing and cutting up and someone happened to look over at John Wayne. He was crying. 


