MENIFEE COUNTY County alcohol sales licenses approved, road projects discussed

At last Friday's regular April Menifee County Fiscal Court meeting, Judge/Executive Rick Stiltner gave several updates, including on local alcohol sales and county road aid funding from the state.

As the county's new alcohol ordinance has taken effect this vear, Judge/Executive Stiltner requested that court members approve opening a new account at Traditional Bank to receive tax funds from alcohol sales.


He reported that three businesses, all Dollar General Stores out in the county, have been approved state licenses to begin selling alcohol.

He also wanted to address false rumors that the county was somehow "holding up" the licenses, when in fact the county has nothing to do with issuing licenses. So far, no business outside of the Frenchburg city limits has applied for a liquor store license.

He also said there has been a license approved for beer sales at the Dollar General Store in Frenchburg as well as a liquor license approved for Ad Mart.

Stiltner said the tax revenue the Fiscal Court collects on alcohol sales can only be spent on alcohol-related matters, including inspections and en-

as general fund money.

Stilter told court members he met the previous day with officials from the Ky. Transportation Cabinet District 10 office from Jackson to discuss county rural road aid. He said the county would be receiving \$84,340 in "Flex" funds for resurfacing, a little more than what was received last year and half of what it received just two years ago. He said every county had seen cuts, and all decisions about county funds were made in Frankfort now, not at the District 10 office.

He said, despite the cuts, Menifee County has among the best roads in the District 10 region. State road projects for the county include 2.6 miles of paving on KY 713, to tie in to Indian Creek, to US 460; paving 713 from the Montgomery County line to East Fork Road; replace pipe on KY 946 on the 9.2 mile marker at Pomeroyton; pave US 460 from Robinfield Road to the Botts store; and pave 746 from the 3 to the 7 mile marker.

Two county road resurfacing projects, Cub Run and

Canyon Ridge, have been approved and will be begin later this spring. Any road projects not approved this year will be resubmitted to Frankfort after July 1, and any discretionary projects will be submitted before October 15 for next year's

General Assembly to consider. Deputy Coroner Alan Michael Peck addressed court members with his office's first quarterly report. He said that the human remains discovered in the Means community are still at the State Medical Examiner's Office in Frankfort, and it would six months or more before DNA testing would be completed. He also reported that his office responded to a call in Morgan County on Ebon Road.

Peck also presented a budget "wish list" to court members, including raises; two additional cots, more evidence bags; the possibility of a twobody morgue and exam room in the county. He said the county currently uses Morgan County's morgue.

Stiltner Judge/Executive said cost-of-living raises are included in this year's budget

for all deputies and a raise for the coroner.

Stiltner also gave good reports for the Menifee County Ambulance Service as well as Edgewood Estate Nursing Home and Rehabilitation. Court members approved Stiltner's request for up to \$25,000 to help the ambulance service meet payroll, if necessary, and for up to \$140,000 to finance a new ambulance van, following a current ambulance blowing a gasket. He said the cost of a new ambulance would be covered by the county's latest round of coal severance funds.

Court members also approved the purchases of a used grader, a small excavator, and a new snowplow truck, at the request of Judge/Executive Stiltner. He explained prior to the vote that the county's grader was damaged, and parts are not available, but the county had received \$50,000 from the insurance company for the damages. The excavator would be used for ditching, and he might consider a lease for it. He also said the new snowplow truck would be paid for with coal severance funds, quoted at \$93,000, for a Ford F-350 with dump bed and snow plow installed.

Court members approved the use of coal severance funds for the snowplow truck purchase as well as up to \$10,000 for new computers for the Sheriff's Office and vehicles.

In other matters: - court members accepted the resignation of A. J. Stevens from the Ambulance Board, because he was serving on it and the Fire Board at the same time, and he is taking over the chairmanship of the Fire Board. Judge/Executive Stiltner said he is asking Larissa Smallwood to serve on the Ambulance Board, as soon as her term ends on the Extension Board
