

One mile of Main Street in Sharpsburg, from Hwy. 36 to the light, got a new coat of asphalt after old black top was milled away last week. The work was completed by the Walker Company. The company submitted low bids to the Bath County Fiscal Court last month, \$46,000 for milling and \$107,256 for paving. The street had gotten into rough shape in the years after it was previously resurfaced in 2014. The project will be paid for out of state Highway Contingency Funds, according to Bath County Judge/Executive Frosty McKenzie.
