

Robinson and the Northern Kentucky Norse visit conference foe

The Detroit Mercy Titans will take on conference opponent Northern Kentucky. Thursday's game will be the second meeting of the season between the two teams. The Norse won the last matchup 73-60. Detroit Mercy is 2-9 against the Horizon League, and Northern Kentucky is 4-6 against conference opponents.

BOTTOM LINE

Orlando Lovejoy and Detroit Mercy host Trey Robinson and Northern Kentucky in Horizon League play Thursday.

The Titans have gone 4-4 in home games. Detroit Mercy is 2-0 in games decided by less than 4 points.

The Norse have gone 4-6 against Horizon League opponents. Northern Kentucky is 2-1 in games decided by 3 points or fewer.

Detroit Mercy is shooting 40.1% from the field this season, 4.2 percentage points lower than the 44.3% Northern Kentucky allows to opponents.

Northern Kentucky has shot at a 42.3% clip from the field this season, 0.5 percentage points less than the 42.8% shooting opponents of Detroit Mercy have averaged.

against the Hoyas his team's best defense-of-fense performance of the season. The lead got as big as 30, and it was over at halftime.

He told players in the locker room that he'd only coached one team that "could go out in the second half, play it 0-0 and dominate" — Kentucky in 1996 on the way

to a national title. St. John's is not there yet, and that's OK to Pitino.

"I'm proud of these guys," he said. "I think the best quality that we have is we're humble. We just keep playing hard. We don't think we're great. We aspire to be great, but we don't believe we're great. We understand that anybody can beat us."
