Greenup man nearing trial may face more charges

GREENUP Prosecutors are in the process of bringing more charges against a Greenup County man already facing multiple sex crimes, but his attorney argues the Commonwealth has already had ample opportunity to do so.

Darrell Wayne Hay, 49, has been held in the Greenup County Jail since August on 10 felony charges, including

two counts of first-degree rape, second-degree sodomy and tampering with physical evidence.

Hay previously pleaded guilty to all 10 counts in the indictment against him.

According to previous reports and court documents, Hay is accused of engaging in sexual intercourse with an intellectually disabled woman, although Hay said he was the one pursued by the woman "prior to her having brain

Assistant Commonwealth's Attorney David Flatt said the prosecution is in the process of appointing a guardian to the alleged victim to represent her interests in court, however with a motion for a speedy trial already entered by Hay's attorney, Bruce Blackburn, the defense argues that should take no longer than a few days.

As far as additional charges, Flatt said the Commonwealth

is just waiting to present new evidence, allegedly uncovered during forensic investigation of an electronic device, for an additional indictment.

Blackburn argued that Hay had been in jail now since August, calling the past eight months "ample time" for more charges to have been presented to a grand jury. Greenup Circuit Judge Bri-

an McCloud scheduled Hay for a pre-trial conference on May 15 to give the prosecution

more time to appoint a guardian to the alleged victim and for the presentation of any more charges to a grand jury.

McCloud said if a guardian had not been appointed and no new charges were added, he would approve the release of Hays from custody pending

the May 27 trial date. The trial is expected to last two to three days.

Summer trial likely in sex crimes case

Currently out of custody, Wampler appeared alongside his defense attorney, Matthew Wisecup, on Thursday in Greenup County Circuit Court.

Per previous reports and court records, Wampler is accused of fondling a child's breast and genital area in 2023, according to the time frame outlined in the indictment.

Wampler is currently set to stand trial on the allegations on July 14 — which as of Thursday shouldn't need to be postponed. Wampler is set for another

pre-trial conference on May.

'Working' 10-year rule when applying for Medicare

Dear Toni,

In February, my husband, James, was laid off and decided to apply for an individual health insurance plan because he is 62 and could not apply for Medicare. I turned 65 in March and am having a stressful finan-

cial issue after enrolling in Medicare. Now my Medicare is costing me \$518 for Medicare Part A and \$185 for Medicare

Part B, totaling \$703 a month! I am completely shocked because my sister is only paying \$185.

I married James 32 years ago and haven't worked much, because I stayed home to take care of our three children. I called the 800-number for Social Security, and the representative said that I had not worked enough time to have Medicare Part A at no cost and that this is my

Please explain what I should do to correct my Medicare problem. Thank you, Toni!

Hi Wendy:

Most Americans are not aware that they must work a certain amount of time, paying employment taxes, to receive premium-free Medicare Part A. This is most likely the cause of your problem. The Toni Says Medicare team helps resolve this issue quite often.

On the medicare.gov website, it states that to qualify for Medicare Part A at no cost you must have worked and paid Social Security and Medicare taxes from your payroll checks for 10 years or 40 quarters. For 2025, if you have paid Medicare taxes for 30-39 quarters, then the standard Part A premium is \$285 each month. If a person paid Medicare taxes for less than 30 quarters — the level at which you qualified, Wendy — then the premium for Medicare Part A is \$518 per month. The extra Part A premium amounts change on Jan. 1 each year, just like Medicare Part B premiums change.

However, those who do not qualify for premium-free Medicare Part A, but who have been married to a current or former spouse for at least 10 years who has met the 10-year requirement, should apply for Medicare under their working spouse's Social Security number. Wendy, this is your issue, since you have been married for 32 years to James, and you should have applied for Medicare under James's Social Security number.

My advice to you would be to contact your local Social Security office, since that is the government office which enrolls Americans in Medicare. Isn't it amazing that it is not Medicare that enrolls Americans into Medicare, but Social Security? Wendy, visit Social Security at: www. ssa.gov/manage-benefits/ make-an-appointment.

You need to schedule an in-person appointment with a local Social Security representative to be sure that your Medicare is processed properly. Ask them for help in appealing the Medicare Part A premium of \$518, because you have been a stay-athome spouse with a husband who has worked enough quarters to qualify for premium-free

Medicare Part A. Social Security will look over your husband, James's, Social Security accounts to verify with the IRS that he has enough quarters to qualify for premium-free Medicare Part A. Be prepared to provide a certified marriage license showing that you and James are married. You will have to provide the original certified marriage license (not a copy) to Social Security.

Those who did not work for 10 years or more to qualify and never married (or lived with someone as a domestic partner) and do not have a certified marriage license, will have to pay for their Medicare Part A premium. And if their spouse/ domestic partner did not work enough quarters, they both will have to pay for their Medicare Part A premiums.

Readers don't forget the "working 10-year rule" when enrolling in Medicare. What you don't know about enrolling in Medicare WILL hurt you! (Chapter 1 of Toni's Medicare Survival Guide Advanced edition can help you avoid problems like Wendy's.)
