# 4 hurt in crash involving school bus

LEWIS COUNTY HERALD REPORT

Lewis County Sheriff’s Deputies are investigating a multiple-vehicle incident Wednesday afternoon involving a school bus and three passenger vehicles.

According to Lewis County Emergency Management Director Dennis Brown, the incident happened on the AA Highway at the intersection of Spy Run Road, just west of Garrison.

Brown said the incident happened shortly after 3:00 p.m. when the Lewis County school bus had stopped in the eastbound lane to drop off a student and two passenger vehicles had stopped behind the bus.

He said a third eastbound vehicle struck the rear of the second stopped vehicle resulting in a chain reaction with the second vehicle then striking the rear of the first stopped vehicle which then struck the rear of the school bus.

He said there were eight stu-

dents on the bus along with the driver and monitor. No injuries were reported aboard the bus.

The driver of one of the vehicles and two passengers in a second vehicle were taken to Southern Ohio Medical Center in Portsmouth, Ohio, by Lewis County EMS.

An occupant of one of the pas-

senger vehicles was airlifted from the scene to a Columbus, Ohio, medical center.

The incident remains under investigation.

Deputies were assisted at the scene by Garrison Fire and Rescue, Black Oak Fire and Rescue, and personnel with the Lewis County School System.

# Ky. GOP senators call for extension of REAL ID deadline

Republicans in the Kentucky Senate are calling on the U.S. Department of Homeland Security to extend a federal deadline set for next month for travelers to have a REAL ID to board domestic flights and access other federal facilities.

A REAL ID is a type of identification card, including driver’s licenses, with enhanced

Congress’ passage of the REAL ID Act in 2005.

After years of delays in requiring usage of these enhanced IDs, Kentuckians and people in other states have until May 7 before a REAL ID is needed to enter federal facilities, such as military bases or to get through airport security checkpoints to board domestic flights.

Sen. Jimmy Higdon, R-Lebanon, in a letter co-signed by other Re-

publican state senators called on Homeland Security Secretary Kristi Noem to extend the deadline because Kentuckians need more time to obtain REAL IDs.

“While the intent behind the implementation of REAL ID is understandable, we believe the practical impact on Kentuckians must also be considered,” Higdon wrote in his April 17 letter. “Despite significant progress, Kentucky is simply not fully prepared for complete implementation.”

Higdon also asked for “more time to help Kentuckians understand that they may not need a REAL ID.” Standard driver’s licenses will still be valid for daily use within the state, he stressed. He encouraged people to review their options and choose the form of identification that best fits their circumstances.

Higdon, the chair of

the Kentucky Senate Transportation Committee, in a column posted to the social media platform X wrote many people have contacted him “about the inconvenience of renewing a driver’s license these days” including long wait times at regional driver’s licensing state offices and a new requirement of a vision test to renew a driver’s license.

A recent report by CBS News found many states are lagging in the percentage of citizens who have a REAL ID. According to data compiled by CBS News from state motor vehicle departments, in 30 states fewer than 70% of IDs are compliant with REAL ID standards. New Jersey had the lowest compliance rate at 17%, while Kentucky had a compliance rate of about 36%.

Higdon in his column wrote that other forms of federal identification, such as passports and passport cards, can be used as an alternative to a REAL ID to get through airport security.

An emailed request for comment sent to a Kentucky Transportation Cabinet spokesperson asking about the letter from state senators was not immediately returned Wednesday afternoon.
