Furthermore, this shelter was funded without using dollars from sources other than diligent budgeting from within and the hard work of the fiscal court, our team members, contractors, LSCC inmates, and our ACO over the last 2 years.

"It is our desire that this location works well serving our ACO and citizens for years to come. Elliott County truly deserves this project, and we are pleased to have it now open."

## Winter Storm Blair hits Elliott County, causes power outages

Winter Storm Blair severely impacted much of the state on Sunday and Monday, Jan. 5 and 6, dropping approximately six inches of snow and a layer of ice in the local area.

The ice and subsequent downed trees resulted in power disruptions, though the Grayson RECC outage map showed no outages in Elliott County as of Wednesday morning.

The inclement weather also prompted numerous church closures on Sunday, as well as several business and government shutdowns and delays during the work week following emergency declarations from Judge Executive Myron Lewis locally and Gov. Andy Beshear statewide.

Elliott County government offices re-opened on regular schedule on Wednesday, thoug schools also remained closed through Friday.

County and state road crews, utility crews, local law enforcement officers, firefighters, emergency personnel and other volunteers worked throughout the storm to clear roads, remove trees, restore services, and assist motorists and others in need.

Judge Lewis gave an update on road clearing operations and also expressed his gratitude to various agencies and individuals via the Elliott County Fiscal Court Facebook page:

Jan. 7 – Good morning. The men will be out again today running chains and spikes on the trucks. The grader will

also be out on the north end, also running with chains.

This ice is extreme difficult to cut through. It takes pressure and patience. The trucks risk overheating issues because of the exertion of gear use in the 4x4 to push the ice & snow while keeping the truck moving forward. In some cases we will have to actually back up a hill and push down due to the weight of salt in the bed. This also doubles the time it takes us to get through each road.

Please be patient. We have had several trucks in ditches and holes. We've also had to stop to go cut trees over roads to make them safe. All of this takes time.

For those of you who have used your own equipment to assist, God Bless you. Just be aware of the danger that mailboxes, drilled steel, culverts, and other challenges we face when out. Do not do anything which may put yourself or your equipment in harm's way.

Thank you to the fire departments, ambulance service, and all other good samaritans who are delivering needed items to our neighbors during this winter season. And for those of you keeping your businesses open so our community can still come and purchase our needed items, thank you too! Just getting to work is a challenge, and we appreciate seeing your lights on!

And shout-out again to the linemen! We've been fortunate that, so far, power losses have been to a minimum, and recon-
