
### **LIHEAP** Crisis applications are open thru March 15th

Comm. action agencies offering heating help across all 120 counties

FRANKFORT, Ky. (January 6, 2025): Kentucky's Community Action Agencies (CAK) are set to begin accepting applications for the Low-Income Home Energy Assistance Program (LIHEAP) Crisis component from January 7 until March 15, 2025, on a first-come, first-serve basis.

This program assists eligible households facing a home heating emergency, such as imminent loss of heat, low fuel supply, or eviction due to unpaid utility bills. Households must meet eligibility requirements, including income eligibility of up to and including 150% of the Federal Poverty Guidelines. Prior LIHEAP assistance does not impact a household's

eligibility. Crisis benefits will cover he minimum needed to alleviate the crisis not to exceed the Community Action Agency's local cost for a deliverable supply of the household's primary heating fuel or \$400 for gas or electric. Households can reapply each time they experience a crisis until they reach their maximum benefit. Benefits are paid directly to the fuel vendor. Kentucky's Community Action Network collectively operates outreach offices in all 120 Kentucky counties. To apply, contact your local Community Action Agency office or call 800-456-3452. WESTWOOD - The recently departed, legendary baseball player turned announcer Bob Uecker once said, "I had slumps that lasted into the winter.'

#### **Elliott County** eligible for **FEMA funds** By TOM LATEK, **Kentucky Today**

FRANKFORT, Ky. (KT), Jan. 16 - The Federal Emergency Management Agency (FEMA) posted a public notice on Thursday that describes FEMA's proposed funding for Kentucky remnants of Hurricane Helene work projects that may adversely affect historic properties, floodplains or wetlands; or may result in continuing vulnerability of these areas to flood damage.

By law, FEMA is required to announce its intent to provide federal assistance and grant opportunities under its Public Assistance and Hazard Mitigation Grant programs, after the Nov. 26, 2024, major disaster declaration for Kentucky due to the remnants of Hurricane Helene.

The major disaster declaration authorizes FEMA to provide, under its Public Assistance Program, reimbursement or direct federal assistance for emergency and permanent work to eligible state and local agencies and certain private nonprofits affected by the Sept. 27-30, 2024, remnants of Hurricane Helene in 34 designated Kentucky counties.

They are Anderson, Bath, Bell, Bourbon, Bracken, Breathitt, Carter, Clark, Clay, Elliott, Estill, Fleming, Franklin, Greenup, Harlan, Harrison, Jackson, Johnson, Lawrence, Lee, Letcher, Lewis, Magoffin, Menifee, Montgomery, Morgan, Nicholas, Owsley, Powell, Robertson, Rockcastle, Rowan, Washington, and Wolfe.

Federal funding also is available on a cost-sharing basis for hazard mitigation measures statewide.

### Kentucky voter registration remains strong

#### Scty. of State reports more than 9,000 new voters registered in Dec.

FRANKFORT, Ky. Jan 17-Secretary of State Michael Adams announced voter registration remained strong in the last month of 2024, with 9,324 voters registering in December.

"It's remarkable that in the month following a presidential election, and 17 months before our next election, Kentuckians showed strong interest in voting," said Adams.

In December, 4,962 voters were removed from the rolls - 4,034 deceased voters, 505 felony convicts, 234 who moved out of state, 98 duplicate registrations, 56 who voluntarily de-registered, and 35 who were adjudged mentally incompetent.

Republican registrants account for 47 percent of the electorate, with 1,674,447 voters. Republican registration rose by 5,263 voters, a .32 percent increase. Democratic registrants make up 42 percent of the
