public input into actionable, state-level policy. We focus on the pressing health issues facing the commonwealth: nutrition shortfalls, ultra-processed and chemically-altered foods, and widespread hunger.

At our first official meeting, members discussed the preliminary goals of the newly-minted taskforce. What did we hope to achieve during the interim period? Overall, members expressed a desire to improve nutritional standards of publicschool lunches, educate people about the benefits of a healthy lifestyle, tackle the growing diabetes crisis, and eliminate countywide food deserts. While this list is by no means exhaustive, it provided a roadmap for members and narrowed the focus of the taskforce.

Using these issues as a roadmap, the taskforce convened the following month to discuss the severe hunger crisis facing Kentucky. Specifi-

cally, members heard testimony regarding the importance of Supplemental Nutrition Assistance Program (SNAP) benefits. As of February 2025, there were an estimated 575,834 Kentuckians enrolled in the SNAP program. This translates to an estimated 12.9% of the state that is reliant on SNAP benefits. However, the SNAP program is an economic boon for Kentucky, with recipients injecting nearly \$1.3 billion into the economy in 2024 alone.

Because of Kentucky's reliance on SNAP, this task force is committed to ensuring that SNAP beneficiaries have access to healthy food options, not just cheap, high-sugar items. One exemplary program that tackles this issue is Kentucky Double Dollars (KDD). Described by the Community Farm Alliance as a "nutrition incentives" program for low-income Kentuckians, KDD partners with local Kentucky farmers and allows them to sell their excess produce for use in the SNAP program. KDD serves over 1,000 Kentucky

farmers each year and operates roughly 80 community-based locations across the state.

However, our success rests upon public engagement with our work. I am heartened by audience turnout and the public input our taskforce has received thus far. After all, creating a healthier Kentucky is a collective
