Breckinridge Circuit Court, Division 2, met on Wednesday, Aug. 20 with Judge Kenneth H. Goff II presiding.

A pre-trial conference was scheduled for October 15.

pleaded not guilty to first degree possession of a controlled substance (meth), first offense; third degree assault / police - probation officer; operating a motor vehicle under the influence of a controlled substance, second offense; obstructing governmental operations; resisting arrest; third degree criminal mischief; and license to be in possession.
