Wildlife officials take action to address deer diseases

Local counties remain under surveillance zone

As deer hunting season approaches, state wildlife officials renewed alerts

and special regulations in place.

The Kentucky Department of Fish and Wildlife Resources urged hunters to review regulations and stay informed about deer health, including the latest disease monitoring updates. In particular, hunters should be aware of the latest information regarding Chronic Wasting Disease and Hemorrhagic Disease.

The reminder issued Thursday about diseased animals in the region came two days after 20 deer were

humanely euthanized at Broadbent Wildlife Sanctuary, a wildlife rehabilitation facility in Meade County, by Kentucky Department of Fish and Wildlife Resources staff.

In response to an inquiry, a department spokeswoman said the animals were being "illegally held at the unpermitted Meade County facility in violation of a state regulation in place to limit the spread of Chronic Wasting Disease."

Office Supervisor Lisa Jackson said the state agency "regrets the need for euthanasia in this situation," but said regulations have been in place to limit the spread of CWD since last October after the Kentucky Department of Agriculture confirmed

After the initial detection, Breckinridge, Hardin and Meade counties were designated as a CWD Surveillance Zone. The department continues active CWD monitoring in these areas and said there have been no changes to regulations in the zone due to the additional verified

Cloverport City Council sets tax rates

The Cloverport City Council voted to set this year's property tax rates during a special meeting Thursday evening.

City Clerk Dawn Lamar read the tax rate ordinance, which sets the real property rate at 31.1 cents per \$100 of assessed valuation and the tangible property rate at 35.3 cents per \$100 of assessed valuation. Both rates are lower than last year's.

After the reading, the city council voted to accept the rates and approve the property tax

In other business, the city council:

*Discussed water bill due dates and disconnections, and voted to set policies related to this matter. Water bills are due on the 10th of each month, and, on the 11th, late notices will be mailed, after which time customers will have 10 days from that date to pay the bill before their service is disconnected. Those who have disputes with their water bill are required to come in to city hall before the 10th, and they will be given 30 days for a resolution and payment of the water bill. After an account has been declared delinquent, the customer can no longer dispute the charges.

*Approved a resolution for Kentucky Waters and the lead line service program.
