

he way we pray as Catholics may seem strange at first

glance, but, if you read these prayers carefully and prayerfully, they are beautiful. You will quickly come to understand the deep devotion Catholics have to Jesus Christ. Here is a prayer you can say for nine days in a row for a special

intention written by the "Priest of the Sacred Heart." (They are a holy order of men in Franklin, Wis.) "O most holy Heart of Jesus, fountain of every blessing, I adore You, and with a lively sorrow for my sins, I offer You this poor

heart of mine. Make me humble, patient, pure and wholly obedient to your will. Grant, good Jesus, that I may live in You and for You. Protect me in the midst of danger, comfort me in my afflictions; give me health of body, assistance in my temporal needs, Your blessing on all that I do, and the grace of a holy death."

We call these nine-

day prayers "novenas." It's taken from Latin: novem meaning nine. For private devotion,

Wills are last option for you to outline property distribution

hen someone dies, one of the first questions asked is what needs to be done to transfer property out of the decedent's name. For many, this is an

urgent issue. Funeral expenses must be covered, bills must be paid and dependents must have transportation.

The first thought is usually to follow the terms of the last will and testament. However, the way in which property is transferred generally depends on the property rather than on the terms of a will.

The first way in which property passes is when property simply remains with a joint owner. Assets passing to a surviving joint owner may be in a deed, title or simply through a jointly

held bank account, but the survivorship language must be included. Property owned

jointly with a right of survivorship is most common for married couples, but also may be used in other scenarios, particularly when a parent adds a child to a

deed or account.

Parents often add adult children to accounts either unintentionally for the purpose of giving the child access to accounts during life or intentionally so the child has access to funds upon death. Assets falling within this category remain

with the survivor with very little, if any difficulty.

The next way in which property passes is through transfer-on-death or paid-ondeath accounts. Transfer-ondeath means that the property, as it is, transfers to the beneficiary, whereas paid-ondeath means the account will be liquidated and paid to the beneficiary. To transfer or cash out the account, a death certificate is required, along with identification for the beneficiary.

For some types of accounts, additional paperwork may be required. For example, to inherit a qualified retirement account, the beneficiary must fill out a form that includes options regarding withdrawals and tax withholdings.

The most common TOD

accounts are investment and retirement accounts, while the most common POD accounts are certificates of deposit, life insurance and checking/savings accounts.

The third way in which property passes upon death is through the use of trusts. Trusts are entities that, like businesses, are set up on paper and have the ability to own property. The person who sets up a trust is the grantor, and the person who manages the trust is the trustee, although for many trusts, both roles are filled by the same person.

Upon the grantor's death, the trust continues to exist and the trustee simply follows instructions for dis-tributing the trust property to intended beneficiaries. Like TOD or POD accounts, trust transfers are fairly quick and require little paperwork.

Although there are some additional ways that property occasionally transfers upon death, such as through a life estate deed or an affidavit of descent, remaining property usually is required to pass through probate court before reaching beneficiaries. This is the time when the will becomes necessary.

A will is the document in which individuals express their preferences for who will handle the work of wrapping up and distributing remaining assets and who will benefit from those assets. The will must be filed with the court so that the court can determine who the rightful beneficiaries are, as well as to give an opportunity to creditors to file claims

against the estate. Beneficiary designations in wills only apply to property passing through the probate court, not through jointly held, POD, TOD or trustowned property.

Property passing upon death rarely passes through one method, as each asset may be held in a different way. By understanding how each asset will pass upon death, individuals can plan their estates to ensure that beneficiaries receive property in the way intended.
