Summer Shade Solar, LLC, is proposing to construct and operate an approximately 106 MW photovoltaic solar energy electric generating and battery storage project and related transmission line (the "Project") in Metcalfe County, Kentucky. The Project will be located to the west of State Highway 163 (KY-163) and near Summer Shade Road and Apple Grove Road. The proposed photovoltaic solar energy project will consist of solar photovoltaic panels and the associated racking systems, electric equipment, project substation and transformer, utility switching station, battery storage system, and underground and overhead electrical connection lines.

The Kentucky State Siting Board on Electric Generation and Transmission Siting is hosting a public hearing in regards to the proposed Summer Shade project (Case No. 2025-00064) on Tuesday, September 9, 2025 at 9:00 am Eastern Daylight Time in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
