The Project will be located to the west of State Highway 163 (KY-163) and near Summer Shade Road and Apple Grove Road. The proposed photovoltaic solar energy project will consist of solar photovoltaic panels and the associated racking systems, electric equipment, project substation and transformer, utility switching station, battery storage system, and underground and overhead electrical connection lines.
