She nursed her for two months and then began radiation treatments. “I am cancer-free today,” she said. “I had another surgery on my ears, and it didn’t take. I’m a proud wearer of hearing aids.” She said it was a “testing of God’s ability. It’s not life over death; it’s faith over fire. It worked out to be a story for his glory.” Bill Old, a member of First Baptist Church in Richmond, said he has been an active pro-life advocate for years. His late wife, Linda, worked at a pregnancy center and he was moved by her actions. “I got interested in the legislative

side of it,” he said. “Churches for long too have held back. The Bible has a lot more to say. It’s not a political issue; it’s a moral issue. God is not Republican, Democrat or Independent. God simply is.” Connie Wason, the president of Madison County Right to Life, was sitting with Old. She said she came to “support the cause.” Tyler McIntyre of Louisville, a member of the Reformed Baptist Church of Louisville, said he wanted to “see our country glorify God through the protection of the unborn. I’m here to protect the rights of life.” Catholic priest Michael Schultz called himself a “huge pro-life advocate.” He was born in Romania and

adopted “because my mother chose life.” “You never know the impact that you’re going to have,” he said, reminding the young people present that “you’re not the future, you’re today.” “We have no idea the impact the Lord has for us. He needs you to make an impact.” David Walls, the executive director of The Family Foundation of Kentucky, called standing for the sanctity of the unborn, “the defining issue of our time.” “Even this General Assembly that’s underway, we’ve seen some good pro-life bills filed and we’ve seen bills that are seeking to move Kentucky backwards and even re-legalize abortion in some context,” said Walls.

“It’s sure an important time and hour to educate and equip the body of Christ, to continue to stand for life, to be a witness to really the whole commonwealth

but certainly to our legislators in this General Assembly, to encourage them to be bold and courageous and move forward on the issue of protecting lives.

I’m just thankful for the opportunity we have to gather pro-life Kentuckians from across the state and stand in unity for protecting lives.”

Said property is to be sold as a whole for the purpose of satisfying the judgment in the amount of \$58,684.13, together with post-judgment interest thereon at the rate of 3.99000% per annum from date of entry of judgment, until fully paid, plus any other charges which have accrued, Plaintiff's costs expended, plus Plaintiff's attorney fees pursuant to KRS 411.195, plus, additional fees, costs and expenses, including advances in payment of ad valorem taxes, insurance premiums, assessments, weatherization, and preservation of the Real Property.
