The hours for the Physical Therapy department will be 8 to 5, Monday through Friday (closed from 12 noon to 1pm for lunch).

The new Physical Therapy building will house two new areas for future plans to be named later. In the original plans the main building was going to be built in the back of the hospital but with a lot of work this property where the building now stands became available.

The community foundation led the way. The Physical Therapy Director Christy Carter spoke, as did Teresa Robinson, Community Foundation Coordinator for New Beginnings Mental Health. Sandy Williams who served at Livingston hospital for 30 years spoke also.

The Community Foundation Center next door will be used for many types of community activities. The center has Christy Carter as the foundation coordinator. She will help by directing these projects including fund raising activities. The Center is where the ribbon-cutting day folks were hosted for refreshments.

Livingston begins search for new superintendent

The Livingston County Board of Education has commenced its search for a new superintendent to succeed Dr. David Meinschein, who will depart on June 30, 2025, to assume a superintendent position with Murray Independent Schools. The Board is committed to a thorough and transparent process to ensure the selection of a strong leader to guide the district. As required by state law, a committee will be established in the following weeks to begin the screening process and make recommendations to the Board on top candidates for consideration. The screening committee is comprised of a board of education member, two educators, one parent, one classified employee, and one

principal. If a district has a minority rate of 8% or more, and no minority member is elected
