National Agriculture Week is March 16-22nd. Since 1770, farming has been the backbone of rural Kentucky, supporting communities and driving local

Webster County is a rural, agricultural county and I've had to honor and privilege to be a part of the agricultural community for the last thirty years and looking forward to many more. Webster County showcases diverse agricultural production. According to the 2022 Census of Agriculture, our county grows corn, soybeans, wheat, and tobacco. We also raise horses, cattle, poultry, sheep, and goats. The Webster County Farmers' Market offers a variety of fresh KY Proud locally grown produce to patrons each week. This variety supports our economy and helps us adapt to changing consumer demands.

Kentucky has 69,425 farms of all sizes. Webster County contributes significantly. Our state ranks first in equine sales, second in tobacco sales, and third in grass hay production. Kentucky is sixth in the nation for the number of farms, with 12.4

million of our 25 million acres dedicated to farming. National Agriculture Week educates the public about agriculture's importance. It highlights where our food comes from, and the role farmers play in providing food, fiber, and fuel. It's a time to celebrate our local farmers, who uphold traditions while embracing modern innovations.

## ${f Free \ Hunter \ Education \ Day \ Scheduled}$

Education RANGE DAY course is scheduled for March 30th. 2025 located at Moffit Lake Recreational Area at 378 Moffitt Lake Road in Union County Kentucky from 2:00 P.M. until 4:00

The course, sponsored by the Kentucky Department of Fish and Wildlife Resources and God's Backwoods Disciples Ministries, includes live fire and a "hands-on" field course. Students will be examined on how to properly carry and use a firearm while in the field and be required to successfully participate in a live-fire exercise.

The Hunter Education RANGE DAY is for those students who have completed the classroom portion by internet.

A course completion card will be issued to successful students state, province or territory in North America. Pre- registration is required for all courses and is completed by visiting the Hunter Education page at fw.ky.

Persons born on or after January 1, 1975, shall carry a valid hunter education course completion card while Kentucky certifications from other states. A bow hunter not in possession of a firearm, may carry a hunter education or a bow hunter education course completion card from any state. Hunter Education certification is in addition to appropriate license and permit requirements. Children must be 9 years old in order to complete the course. Children under age 12, and persons exempt from purchasing a hunting license are

which is valid in any not required to possess a hunter education card while hunting. However, children under age 12 who have not completed hunter education, shall be accompanied by an adult of at least 18 years of age while hunting.

## **Did** You Know?

Scores of people insist that exercising with a partner is a great way to remain committed to a fitness regimen, and now research is beginning to support that assertion.

A 2023 study fromresearchers in Japan published in the Archives of Gerontology Geriatrics found that exercising both alone and with a partner two or more times a week helped to lower risk of cognitive impairment, but the risk was decreased by a more significant margin among those who exercised with others. Authors of the study found that the risk of cognitive impairment decreased by more than 29 percent among individuals who worked out with a partner, which was nearly double the percentage reduction (15 percent) among those who exercised

This ordinance is being repealed as the City of Dixon wishes to combine the efforts of the Tourism Board with the existing Parks, Playground, and Recreation Board.

ORDINANCE RELATING TO PARKS, PLAYGROUND, AND RECREATION BOARD

WHEREAS, the City Commission is desirous of amending the existing Ordinance to as described herein;

NOW, THEREFORE, BE IT ORDAINED by the City of Dixon, Kentucky, acting by and through its Commission, as follows:

§ 33.02 PARKS, PLAYGROUND, AND RECREATION BOARD.

(A) Appointment terms. A Parks, Playground, and Recreation Board is hereby created. The Board shall consist of six not less than 5 persons nor more than 9, appointed by the Mayor and approved by the City Commission, as wel as a City Commiss the Mayor and approved by the City Commission, to serve as follows: the terms of all current members of the Board referenced herein shall hereafter be for staggered expiration terms set by the Commission, and that the members first appointed shall be so appointed that the terms of not more than two members shall expire in the same year. conclusion of Commissioners' regular terms. The City Commissionshall function as a ligison between the City Commission and the Board, and shall only vote on matters before the Board when there is a tie. Each member of the Board shall be subject to a determination and fingerprints with those on file with the Federal Bureau of Investigation, Identification Division and/or the Commomwealth of Kentucky or the Kentucky State Police. Any negative-e report from said agency or agencies will disqualify an individual from st of the background check will be borr by the city. Any member of the board may be removed by a majority

vote of the members of the City Commission.

(B) Compensation. The members shall receive no compensation

for the service as Board members. (C) Duties. It shall be the duty of the Board to review maintenance and equipment of the parks, playgrounds, recreation centers,

and the buildings thereon owned by the City, and to approve qualified directors, supervisors, or other officers as it deems proper to carry out the functions. The Board shall organize and facilitate recreational and fundraiser activities for the general public to enjoy, and may participate m beautification efforts with the City.

(1) The Board shall be guided by a yearly budget and shall be vested with the power to accept any grant, or devise of real estate or any bequest, grant, or gift of money or any donation, the principal or income of which is to be used for parks, playground, or recreation purposes, with approval of the City Commission. Money received for such purposes shall, unless otherwise provided by the terms of the bequest or grant, be deposited into the city's General Parks Board

(2) The City Commission may from time to time appropriate money out of the general fund of the city for the purpose of expanding, equipping, maintaining, and operating such parks, playgrounds, or recreation centers and shall be deposited into the account of the

account and be withdrawn and paid out as hereinafter provided.

(3) All withdrawals from the Board's account shall be signed by the Mayor and City Clerk, or the Mayor Pro Tern and City Clerk, solely for expenses incurred in the acquisition, equipping, maintenance, expansion, and the like of such parks, playgrounds, or recreation cen-

(4) The Park Board Chairman or designee shall present to the full City Commission any requests/plans/submissions for any permanent structure changes or improvements to be made to the parks, for ap-

proval by the full body of the City Commission. (5) The Board shall present to the City Commission at its regular meeting in January of each year an itemized statement showing receipts and disbursements during the preceding year. The Board's

budget shall run on the same fiscal year plan as the city, i.e., from July I to June 30 annually, in conjunction with the city's budget regulations. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is for any reason held invalid or unconstitutional by any

Court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision, and such holdings shall not affect the validity of the remaining portions of Ordinance.

All ordinances or parts of ordinances in conflict herewith, are, to the extent of such conflict, hereby repealed.
