Submission of this form will speed up the approval / reimbursement process once a presidential disaster declaration is approved.

Webster County Jailer’s Report

Webster County Jailer Greg Sauls reports inmates worked a total of 1714 hours between April 6 and April 12, 2025. Hours worked include 850 hours at the detention center; 280 hours at the restricted custody center; 80 hours mowing; 200 hours for Union County; 40 hours for the city of Clay; 40 hours for the city of Dixon; 80 hours for the city of Providence; 40 hours for recycling; 40 hours for the road department shop; 40 hours for the dog warden and 16 hours for Landon’s Hope.

The total jail population is 168 with 49 county inmates; 30 Union County inmates and 89 state inmates.

Twenty-six inmates attended Moral Recognition Therapy; 15 attended anger management; 14 attended Thinking for Good; 15 attended Untangling Relationships and 11 attended parenting classes. Eight

inmates attended GED classes with three graduating and three taking tests.

Dixon City Commission Approves Appointments, Repairs, Purchase

The Dixon City Commission met in regular session on Monday night with Mayor Terry Webb presiding and all commission members in attendance.

Following approval of the minutes from the March meeting and the bills and claims, the commissioners dealt with a varied agenda in a session that lasted about 25 minutes.

Commissioners approved naming Chris O’Leary as the city’s new code enforcement officer. He will receive \$200.00 per month as a stipend, and those payments will be made from the general fund.

In other business, commissioners accepted the resignation of Meghan Harvey as a member of the Parks, Playground, and Recreation board. The commission also approved the appoint of two new members to that board.

Gina Hish and Vanessa Schmidt were presented as the appointees. Commissioner Peggy Poole questioned Ms. Schmidt’s appointment because she does not live within the city limits of Dixon. Ms. Poole told members she felt members of the board should pay city taxes. Commissioner Robert Brown pointed out the Parks, Playground, and Recreation board currently has a member who does not reside within the city limits. Separate motions were made to

accept the appointments of Ms. Hish and Ms. Schmidt to serve a two year term on the board. Commissioners voted 4-0 to accept Ms. Hish’s appointment. The vote was 3-1 to accept Ms. Schmidt’s appointment. Ms. Poole cast the dissenting vote.

The commission approved an expenditure of \$850.00 to purchase Christmas and winter banners to be placed in the city. Commissioners also authorized Mayor Webb to sign a collateral security agreement with United Community Bank.

Commissioner Mande O’Leary was appointed to serve on the parks committee. The commission approved an expenditure \$2,380.00 to A-1 Services for the placement of guttering on the concession stand at Baker Park.

Mayor Webb reported the members of the Dixon Volunteer Fire Department responded to 31 emergencies in March.

The city’s water loss was 17.2% in March. Commissioner Brown told members there is a need to place “No Outlet” signage on Fuqua Avenue and Bourland Avenue.

No further business came before the commission, and the meeting was adjourned.

The next regular meeting of the Dixon City Commission will be Monday, May 12, 6:00 P.M.
