“It means everything,” Hunter said. “We’re a small town, and I hope I’m able to make an impact big enough that people start to learn about our school and town.”

Shelby County head coach Powell Miller praised Hunter’s dedication, calling him a once-in-a-lifetime player who exemplifies hard work,

loyalty, and commitment.

“Giaonni is a phenomenal young man, a great student, and a phenomenal athlete—in that order,” Miller said. “His teammates love him, and he loves going to war for his guys. He was always committed to this program and this community. You don’t get players like him very often, and you have to cherish them while you do.”

Although injuries sidelined Hunter for much

of his senior season, Miller emphasized his lasting impact on the program.

“It stinks that he got injured for most of his senior year, but what we got to see was greatness being put on display,” Miller said. “Even when he wasn’t playing, he still made a difference. I only got to coach him for five games, but I can tell

you—he made my life 20 times easier.”

As Hunter prepares for the next chapter at Centre, he hopes to inspire younger athletes to chase their dreams.

“My advice to younger kids is to pursue their goals and work as hard as they can to obtain a free education,” Hunter said. “Use football as a platform for the rest of your life.”
