a dozen Kentucky lawmakers tricity." went back to the classroom and toured a working power plant as part of the Second Annual Electric University, an effort to provide members of the Kentucky Rural Electric Cooperative Caucus the understanding and realworld experience they need to make informed decisions on energy policy.

Nationally recognized facilitator Bryan Singletary of Practical Energies led an representation before the Electric 101 class for the attendees who represent more than 45 of the commonwealth's 120 counties. The legislators also received a presentation by Dependable Power First Kentucky, a coalition of citizens and businesses concerned about electric reliability. After a safety briefing, the 2025 class toured John Sherman Cooper Power Station near Somerset, where East Kentucky Power Cooperative generates coalfired electricity.

Electric University has received accolades for its handson and transparent engagement between electric co-ops and lawmakers. The class heard from all three power providers that serve Kentucky's electric distribution cooperatives: East Kentucky Power Cooperative (EKPC), Big Rivers Electric Corporation and the Tennessee Valley Authority (TVA). Each power provider answered questions about how they are meeting increased power demands. For instance, at Cooper Station, EKPC plans to add a new 745-megawatt natural gas combined cycle unit.

"We are delighted to provide this opportunity for a first-hand look at energy production in the commonwealth," said Chase Crigler, Vice-President of Government Affairs for Kentucky Electric Cooperatives, the association of all 26 electric co-ops in Kentucky. "This is a pivotal time in the history of energy production in America and Kentucky, and we are so grateful that these dedicated legislators are making a special effort on behalf of their constituents who are also co-op consumer-members."

The Electric University attendees are also members of the Kentucky Rural Electric Cooperative Caucus. Formed in 2023, the co-op caucus now has 101 members, making it the largest of the 26 official caucuses sanctioned by the Kentucky Legislative Research Commission. Among the graduates of the Class of 2025 Electric University was Sen. Aaron Reed, who represents Shelby and Anderson counties. "The specifics of electric generation, transmission and distribution can get very complicated," Crigler said. "As member-owned cooperatives, we have a duty to provide energy facts and be responsive to the questions posed by policymakers. We are honored by the trust of these legislators and pledge to do all we can to partner with them to support


