### NCAA: Basketball tournaments stay at 68 teams this season, talks continue for 2027

The NCAA men's and women's basketball tournaments will not expand beyond 68 teams in 2026, but future growth remains on the radar.

"Expanding the tournament fields is no longer being contemplated for the 2026 men's and women's basketball championships," Dan Gavitt, NCAA senior vice president of basketball, said in a statement on Monday. "However, the committees will continue conversations on whether to recommend expanding to 72 or 76 teams in advance of the 2027 championships."

NCAA President Charlie Baker has said adding teams could add value to the tournament, and he said the NCAA already has had "good conversations" with TV partners CBS and Warner Bros., whose deal runs through 2032 at the cost of around \$1.1 billion a year.

The NCAA Tournament expanded from 64 to 68 teams in 2011. The change introduced the First Four round, a set of pre-tournament games in which the four lowestseeded at-large teams and four lowest-seeded conference champions compete for spots in the traditional 64-team bracket.

Baker indicated in May that the current formula has flaws and said it would be beneficial to give more opportunities to worthy teams.

"If you have a tournament that's got 64 or 68 teams in it, you're going to have a bunch of teams that are probably among what most people would consider to be the best 68 or 70 teams in the country that aren't going to make the tournament, period," Baker

AN ORDINANCE AMENDING SECTIONS 60.003 and 60.014 OF CHAPTER 60 OF THE CITY OF SHELBYVILLE CODE OF ORDINANCES
RELATING TO OCCUPATIONAL LICENSE TAXES AND FEES

This Ordinance amends Sections 60.003 and 60.014 of Chapter 60 of the Shelbyville Code of Ordinances with  $regards \ to \ the \ ownership \ of \ long-term \ residential \ rental \ property. \ It \ eliminates \ the \ rule \ which \ requires \ that \ a \ property \ owner \ shall$ derive at least twenty percent (20%) of their gross income from such rentals or be involved in the management of such rentals for at least twenty percent (20%) of their income-generating activity time, in order for that property owner to be subject to the license fee on income derived from real estate ownership. The new requirement, as stated in Section 60.003(D), reads as follows: "Every person or business entity that collects income from the rental or leasing of two (2) or more units of residential property, or any one (1) unit of residential property that includes more than four (4) separate and distinct sub-units, shall first annually obtain a license from the City Clerk before the commencement of that business, the fee for which shall be seventy-five dollars (\$75.00). The provisions in this subsection (D) shall not apply to a property owner of a unit of residential property in which that property owner lives in one (1) sub-unit of the property, the property includes no more than a total of four (4) separate and distinct sub-units, and the property owner does not collect income from the rental or leasing of any other units of residential property." The category of property ownership described in Section 60.003(D) is subject to the license fee requirements of Section 60.003(A).
