1. Must possess and maintain licensure as a Licensed Practical Nurse (LPN) in Tennessee.
  2. Must possess certification from the American Heart Association in the following:  
\* Cardiopulmonary Resuscitation (CPR)  
\* Automated External Defibrillator (AED)  
\* First Aid
  3. Assume duties delegated by the Registered Nurse (RN) in the school system.
- Duties for children, families, and personnel may include, but are not limited to, medically prescribed intervention, first aid, emergency care, health education, and promotion, health screening, crisis intervention, and communicable disease prevention and control.
4. Administration of medication and treatment prescribed by a licensed health professional, including but not limited to the following:  
Provides skilled nursing care and treatment of identified students according to a plan developed by the RN or other licensed health care provider.
  5. Must be willing to travel between schools as assigned by the RN, the School Health Director, or in the case of an emergency.
  6. Assume other duties delegated by the School Health Director in compliance with the Tennessee Coordinated School Health Program.
  7. Position will begin on or before March 1, 2025. Work days will follow the district's school calendar. The position is paid at a rate of \$28.39 / hourly for 35 hours total per week with a daily work schedule of 7:45 am - 3:15 pm with a 30-minute unpaid lunch period.
  8. Experience as a Clay County Schools employee will be recognized. Healthcare benefits and retirement options will be available.

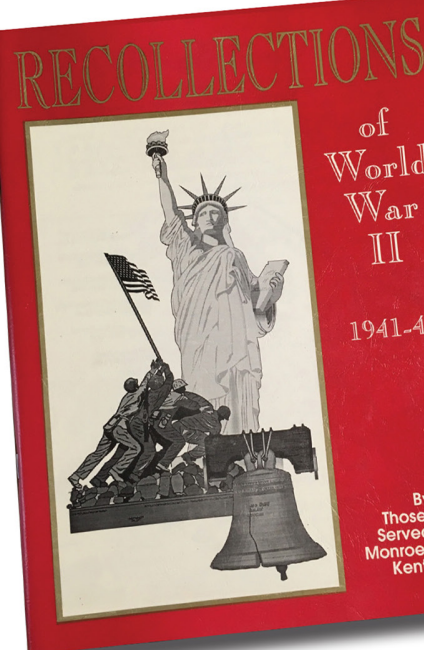
