Pleas

Jose R. Aliva, 22, of Campbellsville, pleaded guilty to first-degree trafficking in a controlled substance and third-degree trafficking in a controlled substance (misdemeanor). The commonwealth recommended five years in prison. Under the plea agreement, receiving stolen property (firearm), convicted felon in possession of firearm, trafficking in marijuana (less than 8 ounces), possession of drug paraphernalia (misdemeanor) and first-degree persistent felony offender charges were dismissed.

Making community safer by ensuring sex offenders comply with the law

A sex offender compliance unit was started in the Versailles Police Department last year to address safety concerns that were expressed in the community, according to VPD Chief Rob Young.

An incident involving a sex offender living in a residence next to a public park (who was convicted of violating sex offender registration requirements) "brought to light" the need to give more attention to making sure sex offenders were complying with the law, Young said.

The compliance unit is headed up by Det. Dawn Monks, who understands why someone living here wants a convicted sex offender removed from a residence located 1,000 feet from a school, licensed daycare or public park. But Monks said she and Officer Jeff Haney must investigate every complaint to ensure a sex offender is violating the law by not complying with residence requirements.

Under state law, anyone charged with a sex offense involving a minor after July 12, 2006 – and subsequently convicted of the criminal offense – cannot live in a residence that is 1,000 feet from a school, licensed daycare or playground/public park, according to KRS 17.500 to 17.580.

"That's the law and we enforce it," said Monks, a veteran of the Versailles Police Department for nearly 23 years.

So at least once a year, Monks and Officer

Jeff Haney check to make sure sex offenders in Woodford County are living where they say they are living, she said. Monks said offenders are given 90 days

daycare opens within 1,000 feet of their home, but most move much sooner than that. If they don't move, they can be charged with failure to comply with sex offender registration requirements – a criminal offense, she said. If sex offenders tell police they were

unaware that a daycare is 1,000 feet from their home, "We will give them the time to move unless there's an extenuating factor that demands (they move) sooner," said Monks. 'And we want the community to be on

alert." she continued. "We want the community to be aware of the (sex offender) registry and who's on it." When people become aware of someone who they think is violating the law, "just let us know. We're always happy to get information that we may not have received," she said.

Monks and Haney also receive email alerts advising them when a sex offender has moved to Woodford County or has moved

We have a very, very good relationship with our probation and parole officers here, said Monks. She added, "I don't feel like Officer Haney and I could do as good a job without their assistance because they can typically find out what we need to know like that," snapping her fingers. "They're very responsive.
