Round Trip, LLC, is proposing to construct and operate a solar and battery energy project in Russell County, Kentucky. The proposed Russell County Solar Park will be located on approximately 450 acres in the vicinity of Old Sano Rd and Bottoms Rd, South of Sano Rd, approximately 5 miles north of Russell Springs. A public meeting to inform the community about the project will take place on Thursday, September 18th, 2025 at 5:30PM Central (6:30PM EDT) at the Russell County Public Library at 535 N. Main St., Jamestown, KY, 42629. Signs will be posted at the library. The meeting is expected to last around 1 hour.

Members of the public are strongly encouraged to attend and participate. If any member of the community wishes to attend virtually, or propose a direct question, please email info@roundtripenergy.com or call (202)-787-8453 at least 48 hours in advance of the meeting to request access to the virtual meeting. An overview of the project, answers to common community questions, and responses to questions submitted in advance will be addressed at the meeting.

The proposed photovoltaic solar project will consist of solar panels installed on racks with an approximate maximum height of 15 feet, inverters, transformers, an energy storage system, associated wiring and balance of system, and a substation. The power generated by the project will be linked to the electric transmission grid via direct connection an existing EKPC transmission substation on or near the property. The project will install a visual vegetative buffer along portions of the perimeter of the project two staggered rows of native, evergreen plantings.
