This past Saturday the Mountain Men Shriners of Meniffee County hosted a presentation at the Frenchburg Fire Station to highlight the services offered by their regional Shriners Hospitals.

Shriners International is a fraternal organization founded 154 years ago which provides hospital care for children in need at no cost to the parents.

Len Noble, Past Potentate, and Steve White, Chief Raban, with the Oleika Shriners Temple in Lexington, opened the presentation and introduced Mike Caldwell, Regional Director for Marketing and Communications with Shriners Children's Hospitals in Lexington and Dayton, Ohio.

Caldwell said the Shriners' hospital's mission is care, education, and research. The Shriners Hospital in Lexington, founded 100 years ago, now works with University of Kentucky Hospital and provides pediatric orthopedic care with state-of-the-art facilities, including advanced EOS imaging and a motion analysis lab, as well as prosthetics construction in-house and surgery.

Shriners' Children's Hospital in Dayton is now part of Dayton Children's Hospital and specializes in burns, cleft palates, scar management, and plastic/reconstructive surgery. This facility provides 1200 surgeries and has 4300 outpatient visits annually.

Caldwell asked everyone to spread the word about Shriners Hospitals services for children. Services are available for children up to age 18, and referrals from a doctor are not required.
