## Garrard County ATC Students Earn Top Honors at Regional SkillsUSA Competition

Garrard County ATC Students from Garrard County Area Technology Center achieved multiple top placements at the annual SkillsUSA competition held Friday, February 20, at the Ignite North campus in Richmond.

Competing against peers from across the region, Garrard County ATC students demonstrated technical proficiency and industry-level skills across a range of career and technical education disciplines, earning several first-, second-, and third-place finishes.

In Carpentry I, Aiden Coffey secured first place, while Gabriel Holt earned third place. In Carpentry II, Syler Skeens placed second and Jared Dotson took third.

The Electrical Motor Controls competition saw Wyatt Rutherford capture first place, with Samuel Prather finishing third. In Electrical Construction Wiring, Seth Whitecrane earned second place and Colton Osburn placed third.

Braxton Ramey achieved a second-place finish in Automotive Maintenance & Light Repair, and Austin Osborn earned third place in Welding II.

Students also excelled in drafting and design categories. In Technical CADD, Abigail Travis earned first place, followed by Madelyn Leger in second and Colin Gilbert in third. In Architectural CADD, William Trimble secured first place, Parker Woolums placed second, and Abigail Bailey finished third.

First-place winners will advance to the state SkillsUSA competition in Louisville, where they will represent Garrard County ATC and compete against top students from across Kentucky.

School officials expressed pride in the students' performances, highlighting their dedication, preparation, and commitment to excellence in their respective trades and technical fields.
