The Lewis County Grand Jury has returned indictments against 10 individuals.

Damien Jacob Hebbeler, 20, of Garrison, was charged of murder, a Capital Offense. On or about August 9, 2023, Hebbeler allegedly, while acting alone or in complicity with another, unlawfully committed murder by shooting Kylie M. Weitz with a handgun causing her death.

Amber N. Frost, 34, of Portsmouth, Ohio, was charged with importing heroin, a class C felony; three counts trafficking in a controlled substance first degree, a class C felony; tampering with physical evidence, a class D felony; possession of drug paraphernalia, a class A misdemeanor; and persistent felony offender second degree. On or about August 8, 2023, Frost allegedly, while acting alone or in complicity with another, knowingly and unlawfully transported any quantity of heroin/fentanyl/carfentanil into the Commonwealth by any means with the intent to sell or distribute the same; possessed a controlled substance, with the intent to distribute, dispense, sell or transfer said controlled substance to another, to wit: (heroin, 2 grams or more, code 42377; cocaine, 4 grams more, code 42368; or methamphetamine, two grams or more, code 42365); destroyed, mutilated, concealed, removed and/or altered physical evidence, which she believed was about to be produced or used in an official proceeding, with the intent to impair its verity or availability; knowingly and unlawfully possessed item(s) intended for introducing into the human body a controlled substance; and by being more than twenty-one years of age and having been convicted of or completed service of a sentence of at least one previous felony within five years prior to the date of commission of the felony for which she now stands charged.

Johnny J. Adams Jr., 54, of Vanceburg, was charged with two counts of first degree trafficking in a controlled substance, a class C felony, and a class D felony. On or about May 5, 2023, Adams allegedly, knowingly and unlawfully distributed, sold and/or transferred a controlled
