# Cats 'meet the moment,' respond after scuffle to blast Georgia State

entucky found another way to keep its perfect record intact and reached the century mark for the fourth time this season with a 105-76 win over Georgia State on Friday night in Rupp Arena.

The eighth-ranked Wildcats matched the Panthers' physicality and delivered the decisive knockout blow following a scuffle that resulted in a flagrant foul and two technical fouls between the two teams with 12 minutes remaining and the Wildcats leading 61-53.

Following the brief altercation, Kentucky scored seven of the next 10 points, and outscored the Panthers 44-23 to close out a fourgame homestand going into a road game at Clemson, followed by a West Coast trip to take on Gonzaga in Seattle.

"I thought it was a great night of basketball, all the saltiness and the whole deal," said Kentucky coach Mark Pope, who walked on the court to help prevent altercation from the escalating. "I thought our guys responded great (after the scuffle). (As) things got a little more intense. I thought our guys really pulled together (and) as such, it was so beautiful to see that as a coach."

Instead of using the scuffle as a distraction, Pope said his squad became focused and sealed the deal down the stretch and he added that proved to be "the difference between winning and losing."

"When things got salty, our guys leaned into each other," the Kentucky coach said. "They looked into each other. They're making eye contact with each other. They were talking to each other, backing each other up. That's what you want from a team."

Kentucky guard Lamont Butler said the Wildcats created a bond amid the chaos. "I think it just brought

us closer together," he said.

"Everybody kind of locked in and we were all ready to fight for each other, to compete with each other. I think they woke up a giant. We made a big run, made some big plays and after that, the dominoes just fell."

Jaxson Robinson, who led Kentucky with 19 points, hopes future encounters won't involve a little pushing and shoving.

"The scuffle kind of got us going in that second half, but hopefully it doesn't take a scuffle for us to be able to play that way," he said. "But, I think it just shows how much fight that we have, just the grit that we have and determination."

Much like an 87-68 win

over Western Kentucky earlier this week, Pope liked the way the Wildcats persevered even when the shots weren't falling early. Kentucky missed its first four 3-pointers and managed just four trevs.

Overall, Kentucky made a season-low seven 3-pointers but scored 62 points in the paint and scored 36 points off 18 turnovers, including 23 during fast-break opportunities to offset the lack of scoring from behind the arc.

"I think we want a different way against Western Kentucky (and) I think we won a different way tonight," Pope said. "I think we have a team that they can meet the moment and will always

strive towards being in the character of what we are. When the game just doesn't play that way, I think we find other ways to win and that's going to be really important for us to be a great team."

For the second time this season, Robinson led the Wildcats in scoring with 19 points. Robinson scored 11 of those in the second half and made eight of nine field goal attempts inside the arc. Lamont Butler, who paced Kentucky with 13 points in the first half, finished with 17, followed by Amari Williams with 14, Ansley Almonor and Otega Oweh with 12 each and Andrew Carr and Koby Brea with 10 each.

## Area boasts tons of quality girls' hoops teams

## **BOYLE COUNTY**

Coach: Brian Britt 2022-23 record: 19-12 Top returnees: Maggie Burke, Jr. G; Addison Yates, Fr. G; Ashlen Young, Jr. G.

Outlook: High energy and aggressive defense drove the Lady Rebels to the area's best turnaround, as they improved by eight wins in Britt's first season and enjoyed their first winning campaign in three years.

That won't change this season as Boyle fields a team that will be very young but also very quick, very athletic and potentially very deep. The nine-player rotation includes four freshmen and an eighth-grader, as well as a couple of girls who haven't played in several years, and that rotation could expand to as many as 11 players.

Burke (6.8p, 3.6r) will lead the way from the point in her second year as a starter, Yates (10.4p, 2.2r) returns to the backcourt after enjoying a breakout season as an eighth-grader and Young (3.2p) is back as the only other girl with significant experience over the past two seasons.

The Lady Admirals feature a strong senior class headlined by Turner (15.2p, 5.1r), who emerged as the team's top scorer last season and should be one of the area's best player this winter.

Doneghy (5.0p, 3.2r), Jackson (3.7p, 4.9r) and Byrd (2.9p) round out the quartet of seniors that Hellyer says is a gritty group; all saw a great deal of playing time last season.

Caldwell (8.2p, 8.4r) also returns after leading the team in rebounding last season and is poised to become a double-digit scorer.
