The Project consists of constructing gravity sanitary sewer lines, manholes and appurtenances in the Balls Branch Sewershed in the vicinity of Gose Pike in Danville, KY.

Bids must be submitted on a unit price basis, as indicated in the Bid Form. Bid security shall be furnished in accordance with the Instructions to Bidders.
