### **RESOLUTION # 2024-3**

A RESOLUTION FOR THE CITY OF FRENCHBURG, KENTUCKY THAT AMENDS THE PURCHASING AND PRO-CUREMENT POLICY TO REQUIRE COMPETITIVE BIDS FOR PURCHASES IN EXCESS OF FORTY THOUSAND (\$40,000.00) AND 00/100 DOLLARS

WHEREAS, the City of Frenchburg, Kentucky adopted a purchase and procurement policy; and

WHEREAS, the KRS 424.260 limited the amount that a city could make expenditures without receiving completive bids to the sum of Thirty Thousand (330,000.00) and 00/100 Dollars; and

WHEREAS, effective June 29, 2023 KRS 424.260 (1)(d) has been amended so that cities may make purchases without competitive bidding for the amounts that are less than Forty Thousand (\$40,000.01) and 01/100 Dollars; and

WHEREAS the City of Frenchburg, Kentucky desires to adopt the requirement under the new KRS statute referenced herein, effective June 29, 2023;

NOW THEREFORE BE IT RESOLVED, the City of Frenchburg, Kentucky adopts the following procurement policy outlined in KRS 424.260(1);

Except where a statue specifically fixes a larger sum as the minimum for a requirement of advertisement for bids, the City of Frenchburg may not make a contract, lease, or other agreement for materials, supplies, equipment, or contractual services other than professional involving an expenditure of more than forty thousand dollars (\$40,000) without first making a newspaper advertisement for bids. This policy will not apply to the transfer of property between governmental agencies as authorized in KRS 82.083(4)(a).
