Wildcats end the regular season 3-7, after loss to the Bluejackets

The Bath County Wildcats football team traveled to Nicholas County to take on the Bluejackets on Friday, Nov. 1, 2024, at Ben Pumphrey Field, in Carlisle, Ky., for their final game of the regular season, and walked away with a loss, 44-36.

The Wildcats three regular season wins were on Sept. 28th against Lewis County (42-12), on Oct. 11th against West Carter (26-20), and on Oct. 25th against Fleming County (36-35).

The Wildcats started the game off against the Bluejackets with a bang, scoring a touchdown on their 2nd play during the 1st quarter, taking an early 7-0 lead, and scoring a touchdown late in the 2nd quarter, tying the game up at 22-22, and giving them some much needed momentum going into halftime. But a Wildcats fumble during the 3rd quarter that was recovered by Nicholas County and the Jackets 3 touchdowns, compared to the Wildcats 2 touchdowns, were no match, as the Cats fell to the Jackets, with a final score of 44-36.

Wildcats QB Cole Hart went 7 for 11 for 99 yards, including 2 touchdown passes to Montana Brashear, and 1 interception. Brashear had 4 receptions for 66 yards, which included his 2 touchdowns; while Logan Jones had 2 receptions for 21 yards; and Preston Roussos had 1 reception for 12 yards, and

4 PAT's.

The Cats had a total of 180 rushing yards, led by Zachary Hardin with 2 rush attempts for 69 yards, including 1 touchdown; Cole Hart with 10 rush attempts for 67 yards, including 1 touchdown and 1 2-point conversion; Parker Crouch with 9 rush attempts for 34 yards; and Logan Jones with 1 rush attempt for 10 yards, resulting in a touchdown.

The Cats defense had a total of 126 tackles (79 solo and 47 assisted) against the Bluejackets, led by Elias Armstrong with 19 tackles; Jordan Yates with 16 tackles; Cole Hart with 16 tackles, including 2 tackles for loss; Nathan Tripp, Carson Cline, and Zachary Harding with 12 tackles; and Parker Crouch with 12 tackles, including 1 tackle for loss.

The Bath County Wildcats move on to the 1st round of the Class 3A 2024 UK Healthcare Sports Medicine State Football Finals, where they will take on the Lloyd Memorial Juggernauts on Friday, Nov. 8, 2024, at 7:00pm, at Lloyd Memorial High School, in Erlanger, Ky.
