Grand Jury Returns INDICTMENTS

The Allen Grand Jury met November 27 and returned the following indictments.

Fiscal Court Holds Routine Meeting

The Allen County Fiscal Court held their regular meeting Tuesday, Nov. 26, 2024 at Adolphus Volunteer Fire Department, Andrew Jackson Highway with all magistrates present and Judge-Executive Dennis Harper presiding.

The November 12, 2024 Court minutes were approved with no corrections or additions noted. The bills list was presented with highlighted transactions reviewed as each county volunteer department will receive \$19,778.10 from tax receipts and Fountain Run Volunteer Department will receive \$1,000.

The CORE budgeted swim program of \$4,500 was presented in November. Since 2006, the CORE of Scottsville has hosted over 250 secondgrade students every spring for free lessons on swimming and water safety. "Second Grade Swim" was created after a young man in Allen County drowned in Barren River Lake in April 2006. That year, community leaders convened and made it a priority that all Allen County youth have the opportunity to learn the potential dangers of the water in their community. While each student does not necessarily leave as a strong swimmer, they do leave with an understanding of basic water safety

Transfer Station Director Derrek Isenberg thanked the court for addressing the lighting within the facility and OSHA compliance is up to date currently. Isenberg related an ongoing pursuit of a vendor to handle plastics recycling, yet no available solution has been obtained to handle plastics within the Transfer Station.

Sheriff Brandon Ford expressed the department is running smoothly as well as still collecting 2024 property tax receipts and wished everyone a safe and enjoyable Thanksgiving.

Judge-Executive Harper reported the sidewalk construction has started at the Fred Hale Ballpark playground and will be very nice to meet the needs of participants using the playground equipment. The Allen County Park has most of the sewer lines installed and water lines are currently being finished as well.

Nominations approved for Allen County Extension Board were Margaret Ann Vick and Ann Barton for threeyear terms. The magistrates also approved Luc Graves to fill the vacancy of John Hall term with the Scottsville-Allen County Planning and Zoning Commission.

Criteria to beginning the bid process for 2025 purchases of tractors and mowers is almost ready for a public announcement.

Magistrates approved the transfer of \$12,000 from the general fund to the jail fund and the October Treasurer's Report was received for filing.

Jailer Tim Meador reported the current census as 60 male and 20 female, amounting to 37 county and 43 state inmates with the most common charges as failure to appear (43) and probation violation (46) activity. The work release program has collected 2,330 bags of trash amounting to 53,674 pounds along with 190 tires and 29 dump sites cleaned up year to date.

Gary Petty, director of Allen County-Scottsville Rescue Squad, informed the magistrates a \$46,000 application for funding a truck is being sent to Kentucky Division of Emergency Management grant program and feels confident Allen County will qualify for some of the appropriated funding.

The 2025 Meeting, Holiday and Committee Schedules were presented to the magistrates and a motion to table any amending or approval of the schedules for the next meeting was passed, giving the magistrates time for review.
