By ordinance adopted on December 9, 2024, the City of Irvine adopted a cable franchise ordinance authorizing the acceptance of bids pursuant to the terms of said ordinance. ORDINANCE NO. 25-04 CITY OF IRVINE, KENTUCKY

AN ORDINANCE RELATING TO THE ESTABLISHMENT OF A CABLE FRANCHISE

AN ORDINANCE CREATING A FRANCHISE FOR THE ERECTION, LAYING AND MAINTENANCE OF TELECOMMUNICATIONS FACILITIES AND APPURTENANT FACILITIES AND EQUIPMENT IN, ALONG AND ACROSS THE PUBLIC WAYS, ROADS, STREETS, ALLEYS AND OTHER PUBLIC PLACES IN THE CITY OF IRVINE, KENTUCKY: FOR FURNISHING AND SELLING OF CALBE TELEVISION SERVICES; AND PROVIDING FOR THE SLAE OF SAID FRANCHISE.

“BE IT ORDAINED BY THE CITY OF IRVINE, KENTUCKY”:

An ordinance creating a franchise for the erection, laying and maintenance of cable television facilities and appurtenant facilities and equipment, in, along and across public ways, roads, streets, alleys and other public places in the city of Irvine, Kentucky, for furnishing and selling of cable television services by means of said facilities; and providing for the sale of said franchise for a term of ten (10) years; and setting the effective date of the franchise.
