AG sues TikTok on behalf of Kentucky kids

FLORENCE — Attorney General Russell Coleman announced last Wednesday the filing of a lawsuit against TikTok and its affiliated entities for the social media platform's exploitation of Kentucky's young people to turn a profit.

Coleman alleges this Chinese social media platform engaged in predatory behavior to suck in minors, leading to depression, anxiety, altered development, lack of sleep and more.

"TikTok was specifically designed to be an addiction machine, targeting children who are still in the process of developing appropriate self-control.

"It doesn't take much

"It doesn't take much for our kids to fall headfirst into a digital world of unrealistic beauty standards, bullying and low self-esteem," Coleman said.

"If we don't hold Tik-Tok accountable, our children will suffer the very real consequences. Nothing less than their mental, physical and emotional health are on the line."

In 2022, TikTok reportedly had nearly 100 million U.S. monthly active users and generated an estimated \$9.4 billion in revenue.

By addicting young

people to spend endless hours on the platform, TikTok can deliver them to advertisers and collect a hefty profit, Coleman said. He quoted one TikTok

executive as saying, "Teenagers in the U.S. are the golden audience."

The lawsuit, filed in Scott County Circuit

addictive content system to maximize the amount of time young users spend on the platform;

 Designed features that exploit children's psychological vulnerabilities;

Engaged in a scheme to deceptively market the platform and its features;
Refused to address the

accessibility and spread of child sexual abuse material on the platform.

Coleman joined a bipartisan group of attorneys general in filing separate enforcement actions to hold TikTok accountable for its role in worsening children's mental health, including from California, New York, Illinois, Louisiana, Massachusetts, Mississippi, North Carolina, New Jersey, Oregon, South Carolina, Vermont, Washington and the District of Columbia.
