

# **McElfresh retires from dentistry practice after 48 years**

BUTLER — Dr. Monte McElfresh wears many hats - Christian, husband, father, grandfather, preacher, musician, avid Řentucky Wildcat fan and local den-

On Sept. 26, this Pendleton County native retired after 48 years of practicing dentistry.

Upon his graduation from Bracken County High School (he spent all but his last year in Pendleton County schools), McElfresh paid an employment agency in Cincinnati to help him secure a job.

He took a job at a dental lab making crowns and bridges, working during the summers, on weekends, and during breaks from col-

He found that he enjoyed the job and began working towards his DMD from the University of Kentucky College of Medicine. In 1976, McElfresh

opened a general dentistry practice in Augusta. Over his career, McEl-

fresh had offices in Augusta, Brooksville, and Butler. But his dental expertise extended much farther than Bracken and Pendleton Counties.

After McElfresh was ordained as a Baptist preacher in July 2001, ĥe began taking his dental techniques to the mission field. This took him to Honduras ten times and India six times, performing oral surgery and general dentistry in the tribal villages of these places.

"It was very primitive but rewarding," McElfresh said.

He told how the "pa-tient chair" was a lawn chair; there was no electricity, so everything had to be battery operated; and the only dental tools available were those he brought from home.

When asked why he stuck with dentistry for so long, McElfresh said that he loved the job and still loves it but admitted that he doesn't care for the necessary administrative part of his job.

During his years as a practicing dentist, McElfresh had family members by his side in the various offices.

His wife of 52 years, Myrna, helped with administrative tasks, but also worked chairside with her husband before becoming a middle school science teacher in Campbell Coun-

His three children spent time assisting in the office, as needed.

McElfresh stated that he is grateful to the many patients who entrusted him with their care over his 48 years in dentistry.

He may be out of the dental office but can still be found preaching at Fairlane Baptist Church, Alexandria. You also never know where he may show up, blessing others with his musical talent; like singing at Second 12 Mile Baptist Church revival last week.

He sold his practice to Dr. Christian Zint who will continue the Butler dental practice at 8636 U.S. Highway 27, Butler.

#### **CITY OF FALMOUTH ORDINANCE # 2024:9**

#### AN ORDINANCE OF THE CITY OF FALMOUTH, IN PENDLETON COUNTY, KENTUCKY, AMENDING THE ANNUAL BUDGET (ORDINANCE NO. 2024:4) FOR THE FISCAL YEAR JULY 1, 2024 THROUGH JUNE 30, 2025, BY ESTIMATING **REVENUES AND RESOURCES, AND APPROPIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT.**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF FALMOUTH, PENDLETON COUNTY, KENTUCKY AS FOLLOWS:

**SECTION 1:** The annual budget for the fiscal year beginning July 1, 2024 and ending June 30, 2025, as set forth in Ordinance No. 2024:4, is amended as follows to include revenue for the following:

Expense:

\$450,000.00

That these amounts are to be included in the 2024-2025 Falmouth Budget, as if set forth in the Ordinance No.2024:4, and expended for the water/sewer projects/upgrades approved by Council.

That all other budgeted items set forth in Ordinance No. 50.01-2019, shall remain in effect, until further amendment

**SECTION 2:** This Ordinance shall be effective upon passage and publication.

**SECTION 3:** The Invalidity of any section of this Ordinance shall not affect the

validity of any other section.

- **SECTION 4:** 
  - This Ordinance shall be published in Summary according to law.

**SECTION 5:** The foregoing Ordinance was read, passed, and adopted by the

Council of the City of Falmouth, Kentucky, meeting in special session on the 3rd day of October 2024, and in regular session on the <u>17</u> day of October 2024. Approved by the Mayor and ordered published in Summary according to law.
