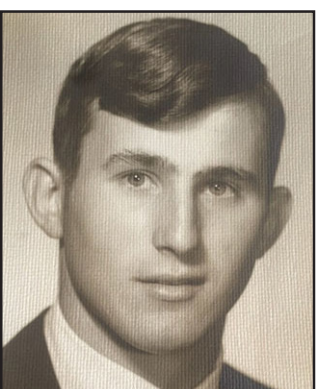

Harrodsburg, the Republican incumbent, Rep. Kim King, defeated the Democratic challenger, Katrina A. Sexton, 8,465 to 3,232. King earned 72.37 percent of the votes. Justin Johnson, who was running unopposed for the commonwealth's attorney seat, and incumbent Allison B. Buchanan, who was running unopposed for the circuit court clerk, both won their elections.

collecting 129 votes.
Mercer County voters voted overwhelmingly in favor for allowing the sale of medical cannabis at a local dispensary and the operation of other cannabis businesses, 7,503 to 3,850.
There are also two constitutional amendments. The first, which asked if voters were in favor of amending Sections 145 and 155 of the state constitution to prohibit persons who are not citizens of the United States from voting in Kentucky, passed, 7,338 to 3,691.
The second constitutional amendment, which would have enabled the General

Assembly to provide financial support for the education costs of students in kindergarten through 12th grade who are outside the system of public schools, failed, 7,530 to 3,982.
Six people were vying for the four seats on the Harrodsburg City Commission. Incumbents Kerry Anness (1,199 votes), Marvin "Bubby" Isham (1,626 vote) and Charlie Mattingly (1,490 votes) won reelection. Former city commissioner Jack L. Coleman won the final seat, collecting 1,512 votes.
Burgin voters elected to go wet, 320 to 228.

Assembled by the Burgin Independent School District race, the incumbents, Ben Bradshaw and Keith Monson, both won reelection, earning 843 and 720 votes, respectively.
In the Burgin City Council race: incumbents, Jamie Keebortz (243 votes), Travis Irvin (239 votes) Melinda Wofford (215 votes) and Sindicat "Sid" Dunn (197 votes) all won re-election. Sarah Moran, who has not served on the council before, won a seat, collecting 212 votes. Former mayor and city councilman George Hensley, who filed to run as a write-in candidate, won the final seat,
