

Eminence cross country competes in Meet of Champions

The Eminence cross country team traveled to Lexington on Oct. 19-20 to compete at the KTCCCA Meet of Champions.

Three Warriors took part in the boys 5K event. Joey Reed led Eminence in 69th place with a time of 19:38.03.

Austin Landers followed in 112th place with a time of 20:35.19 and Connor Yenshaw rounded out the event for the Warriors in 163rd place with a time of 21:40.29.

In the girls 2K run for fourth grade and under, Charlsie Parker placed 42nd with a 9:58.68 and Elaina Rutledge came in 45th with a 10:00.39.

Aubree Veech also earned 212th with a time of 12:24.46.

In the boys 3K run for sixth grade and under, Gavin Lankford led Eminence in 55th place with a 14:04.35.

Brynlee Yenshaw paced the Warriors in the girls 4K middle school event with a time of 17:53.77 for 12th place. Ava Bitterman added a time of 20:57.94 for 62nd place.

Jackson Reed led Eminence in the boys 4K middle school race, clocking a time of 16:24.06 for 26th place.

In the boys 2K run for fourth grade and under, Ezekiel Ison finished 49th with a time of 9:19.01 and Michael Spiegl earned 53rd with a time of 9:23.19.

Kentucky Fish and Wildlife Commission Member Nomination Meeting

A meeting to nominate candidates for the 5th District representative on the Kentucky Fish and Wildlife Commission will be held Nov. 21 at the Boone County Enrichment Center, 1824 Patrick Dr., Burlington, Ky. The meeting will start at 7:30 p.m. (Eastern time). Doors open at 6 p.m.

The commission provides oversight of the Kentucky Department of Fish and Wildlife Resources and guides development of the state's regulations on hunting, fishing, boating and related matters.

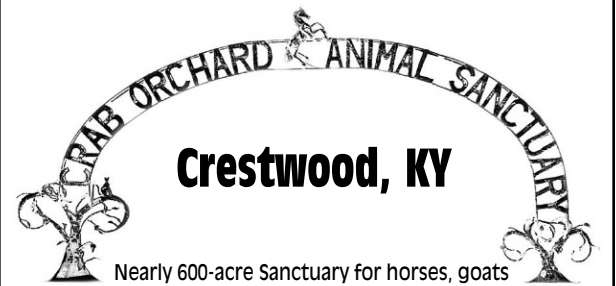
Resident hunters or anglers of the 5th District who, for the past 2 consecutive years, have held a Kentucky hunting or fishing license or hunted or fished in Kentucky while license-exempt under KRS 150.170, may participate in the nomination meeting. The 5th Wildlife District includes Boone, Bracken, Campbell, Carroll, Gallatin, Grant, Harrison, Henry, Kenton, Owen, Pendleton, Robertson and Trimble counties.

Nominees must: be a current resident of the district; not be a convicted felon; have held hunting and fishing licenses for at least the previous 5 consecutive years or hunted and fished in Kentucky while license-exempt under KRS 150.170; and be well informed about wildlife conservation and restoration. The names of nominees chosen at the meeting will be submitted to the governor, who will appoint one of the nominees, subject to Kentucky Senate confirmation.
