Notice is hereby given that the Kentucky Public Service Commission ("PSC") will conduct a public hearing in Case No. 2024-00115 beginning at 9:00 a.m. Eastern Standard Time on Thursday, December 19, 2024 in the Richard Raff Hearing Room (Hearing Room 1) at its offices at 211 Sower Boulevard, Frankfort, Kentucky 40601, for the purposes of cross-examination of the witnesses of Kentucky Power Company and taking evidence on the issues in PSC Case No. 2024-00115 regarding Kentucky Power Company's application to expand its existing demand-side management program (the Targeted Energy Efficiency Program) and approve two new demand-side management programs (the Home Energy Improvement Program and the Commercial Energy Solutions Program). This hearing will be streamed live and may be viewed on the PSC website at psc.ky.gov. Public comments may be made at the beginning of the hearing. 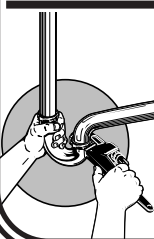
