

62nd District Baseball Tournament

Raiders use the long ball to power past Morgan in district championship

East Carter scored five runs in the second inning before adding four in the fifth as the top-seed cruised to a 12 – 3 win over the Cougars in the 62nd District title game last Thursday (May 18) in Olive Hill.

With the victory, the Raiders extended their win-streak to 10-consecutive games, improving to 26-5 overall and undefeated (5-0) in district play. East hasn't lost in the month of May, with the last setback coming at Ashland (9-8) on April 27.

The Raiders got on the board in the second when Levi Hutchinson doubled to left and Tate Scott, Evan Goodman and Andrew Tomolonis all reached on infield errors, leading to a pair of runs. Those Cougar three miscues proved extra costly when Ty Scott launched a two-run homer to center field for the early 5 – 0 lead.

East scored lone runs in the third and fourth inning for a seven-run advantage. The Cougars got three back in the fifth when Dawson Yeary was hit by a pitch, followed by hits from Conner Fleming and Colten Conley. All three players would score on either a wild pitch or passed balls to trim the deficit to four.

However, East responded the following inning with a timely two-run homer from Goodman, scoring Scott in front of him. The Cougars gifted two more runs on passed balls as Tomolonis and Blake Hall raced home to make it 9 – 3. The Raiders pushed across their final run in the sixth on an RBI single to center by Hall.

Tate Scott led East with three hits and as many runs scored. Hutchinson had a pair of hits and scored a run while Goodman, Hall and Tomolonis each scored twice. As a team, East banged out 11 hits with seven RBI's and 11 bases-on-balls.

Morgan managed six hits, led by two from Yeary and one each by Dawson Hampton, Conley, Cooper Fleming and Conner Fleming.

Tomoloinis was credited with the win for East, allowing just one hit with eight K's through four innings. Connor Skaggs gave up two hits and three runs (two earned) in one inning of work. Harley Bowen threw the final two, allowing three hits and no runs while striking out one and walking

Eli O'Quinn was tagged with the loss for Morgan, despite not allowing an earned run. The senior faced 14 batters and threw 27-of-43 pitches for strikes, but four errors led to five Raider runs. Cole Adams and Hampton combined to work the final three, surrendering eight hits and seven earned runs.

The Cougars' season comes to an end with a 14-19 record, including 8-14 within the 16th Region and 5-3 against district foes.

16th Region Baseball Tournament

Raceland stays hot, eliminates Cougars from postseason play

Raceland scored in every inning, highlighted by a combined nine runs in the third and fourth, as the Rams beat Morgan County, 13 – 3, in the opening round of the 16th Region Tournament in West Liberty.

Raceland entered the tournament having won five of its last six games, including a 12 – 2 road victory over the Cougars on May 6. The Rams had scored 260 runs on the season—good enough for 3rd best in the region. As a team, Raceland was hitting an impressive .322, including 65 extra base hits.

Clay Coldiron led the way in this game, collecting four hits, four runs scored, two RBI's and five total bases. The Cougars had no answer for the Rams' senior as he singled in the first, doubled in the third and singled again in both the fourth and fifth innings. Coldiron also added five stolen bases.

Parker Fannin, Eli Lynd and Brayden Webb had two hits apiece as part of a 14-hit day for the Rams. The team walked five times and had 10 stolen bases in as many attempts.

Meanwhile, Connor Thacker was solid on the mound for Raceland, allowing five hits and three runs (one earned) over five innings, striking out six and walking three. It marked Thacker's fifth win of the season without a loss. The sophomore has a stellar 1.25 ERA.

Dawson Hampton led the Cougars with two hits and a run scored while Cole Adams, Conner Fleming, Colten Conley and Cooper Fleming had a hit apiece. The Cougars had 20 official at-bats, but only seven total bases. The team's biggest offensive inning came in the fourth as Conley and Fleming
