Fiscal Court approves alcohol ordinance on second reading during Dec. 18 meeting

Members also approve proposed budgets for county clerk, sheriff; minutes are listed

The Morgan County Fiscal Court during a special Dec. 18 meeting approved an Alcoholic Beverage Control (ABC) ordinance on second reading.

Judge Executive Jim Gazay said after the meeting – which the Courier did not attend that the following key points introduced during the ordinance' first reading on Dec. 10 remained the same:

• Hours Of Operation For Alcohol Sales - 6 a.m. to midnight, Monday through Saturday. There will be no Sunday sales.

• Non-Operating Hours Restrictions – Cooler doors must be locked, and cash registers

restricted to prevent sales. • Sales Tax - A 5 percent sales tax will be imposed, aligning with the City of West

Liberty's rate. Though no Alcoholic Beverage Control (ABC) administrator was appointed, Judge Gazay agreed serve in this capacity on a strictly temporary basis until a permanent officer is hired and the position is funded.

Judge Gazay reiterated that he had no desire serve as ABC administrator on a permanent

The judge executive also previously stated during the Dec. 10 meeting that he has no intention to apply for an alcoholic beverage sales license, which is prohibited among ABC administrators.

Following the Dec. 10 meeting, Judge Gazay told the Courier of a similar plan in Menifee County – which also approved alcohol sales in November regarding a temporary ABC administrator.

On a motion made by Magistrate Brandon Evans and seconded by Magistrate Tommy Fannin, the court unanimously approved the ABC ordinance with amendments regarding keg regulations, sidewalk cafes cups outside venues.

and the restriction of plastic In other news, the court unanimously approved the following proposed budgets for

the 2025 calendar year: County Clerk Randy Wil-

liams' Office – This budget was presented as a whole, subject to audit. Additionally, the maximum total for deputies' salaries was set at \$211,000.

• Sheriff Greg Motley's Office - This budget was presented as a whole, subject to audit. Additionally, the maximum total for deputies' salaries was set at \$875,000 (amount also includes Sheriff Motley's salary), with the court agreeing to reimburse the sheriff's office excess fees, and to allow the sheriff to participate in the state advancement program.
