BrucePac ready-to-eat products recalled following USDA testing

Nearly 10 million pounds of ready-to-eat meat and poultry products are being recalled by the manufacturer, the U.S. Department of Agriculture's Food Safety and Inspection Service

The federal inspectors say the products made by BrucePac, a Durant, Oklahoma, company, may be adulterated with Listeria

The ready-to-eat items were produced from June 19 to Oct. 8. These products were shipped to other establishments and distributors nationwide then distributed to restaurants and institutions.

The products subject to recall bear establishment numbers "51205 or P-51205" mark of inspection. More information regarding labels

provided when available, the USDA statement said.

The problem was discovered after inspectors performed routine testing of finished product containing poultry products produced by BrucePac. The testing confirmed those products positive for Listeria monocytogenes. Subsequent investigation identified BrucePac RTE chicken as the source of the Listeria monocytogenes.

> Consumption of food contaminated with L. monocytogenes can cause listeriosis, a serious infection that primarily affects older adults, persons with weakened immune systems, and pregnant women and their newborns. Less commonly, persons outside these risk groups are affected.

Listeriosis can cause fever, There have been no muscle aches, headache, stiff neck, confusion, loss of balance and convulsions sometimes preceded by

beyond the gastrointestinal tract. In pregnant women, the infection can cause miscarriages, stillbirths, premature delivery or life-threatening infection of the newborn.

In addition, serious and sometimes fatal infections in older adults and persons with weakened immune systems. Listeriosis is treated with antibiotics. Persons in the higher-risk categories who experience flu-like symptoms within two months after eating

diarrhea or other gastro-contaminated food intestinal symptoms. An should seek medical care invasive infection spreads and tell the health care provider about eating the contaminated food.

The Food Safety and Inspection Service statement expressed concerned that some product may be available for use in restaurants, institutions and other establishments. These other establishments may have used affected meat and poultry in ready-to-eat products that may be on store shelves or in consumers' refrigerators or freezers.

CITY OF SPRINGFIELD ORDINANCE NO. 2024-017

AN ORDINANCE AMENDING WATER AND SEWER SERVICE RATES FOR USERS OF THE PUBLIC WATER AND SEWAGE TREATMENT SYSTEM.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SPRINGFIELD, COMMONWEALTH OF KENTUCKY:

SECTION 1. The Springfield City Council, having considered the recommendation of the Springfield Water and Sewer Commission that it has become necessary to amend existing water and sewer service rates in order to adequately fund existing operation and maintenance functions of the water company and the sanitary sewer system, does hereby revise the schedule of rates and charges for use of and services rendered on the municipal water and sewer system of said City by amending Sections 1 of Ordinance 2016-004 and Section 3 of Ordinance 2019-007 as follows:

SECTION 1 (Ordinance 2016-004)

FAIR HOUSING LAWS

The Federal Fair Housing Act prohibits discrimination in the sale rental, leasing and financing of housing, as well as discriminatory advertising, on the basis of RACE, SEX, COLOR, RELIGION NATIONAL ORIGIN, MENTAL or PHYSICAL HANDICAP, or FAMILIAL

"These laws cover any potential or actual sale, lease, rental, eviction price, terms, privileges or any service in relation of the sale of or use of housing. They not only prohibit advertisements that clearly restrict access to housing based on the protected categories, but also prohibit advertisements that indicate a preference for or against a person based on a protected category. In particular circumstances, use of colloquialisms, symbols or directions to real estate for sale or rent may indicate a discriminatory preference."

'It is the intent and goal of this newspaper to have each advertiser who wishes to place a covered advertisement in the newspaper comply with the Fair Housing laws. Any advertisement that is perceived to contain language contrary to these laws will be rejected or changed to remove the offending reference. There may be situations where it is not clear whether particular language is objectionable. Such advertisements should be referred to a supervisor for consideration and determination. Under certain circumstances, advertisers may claim that because of the nature of the housing being advertised, they are not subject to the Fair Housing laws. Such claims are irrelevant for purposes of considering advertisements for publication in this newspaper. Every housing advertisement published in this newspaper is subject to the Fair Housing laws."

ORDINANCE NO. 2024-018 ORDINANCE AUTHORIZING ALL CANNABIS BUSINESS

OPERATIONS IN THE CITY OF SPRINGFIELD WHEREAS, on March 31, 2023, the Governor signed into law Senate Bill 47 which establishes the licensing and regulation of the cultivation, processing, sale, distribution, and use of marijuana and

related activities for medicinal purposes; and WHEREAS, the Act authorizes the Cabinet for Health and Family Services to issue licenses to the following businesses

- (a) Tier I cannabis cultivator;
- (b) Tier II cannabis cultivator; (c) Tier III cannabis cultivator;
- (d) Tier IV cannabis cultivator;
- (e) Cannabis dispensary;(f) Cannabis processor; (g) Cannabis producer; or
- (h) Cannabis safety compliance facility; and WHEREAS, KRS 218B.130 authorizes a local government to authorize, prohibit, or submit to referendum vote the question of cannabis business operations within its territory; and

WHEREAS, the commonwealth of Kentucky legalized medicinal cannabis to provide qualified patients with severe medical disorders

to utilize medicinal cannabis under a doctor's care, it is necessary and appropriate, and in the best interest of the health, safety, and welfare of the City of Springfield's residents and members of the public who visit, travel or conduct business in the City of Springfield to authorize all cannabis business within the geographic boundaries of the City of Springfield; and

WHEREAS, the City of Springfield wishes to utilize the authority granted to it by KRS 218B.130.

NOW, THEREFORE, BE IT ORDAINED by the City of Springfield as

Section 1

Definitions (1) "Cabinet" means the Cabinet for Health and Family Services;

- (2) Cannabis business" means an entity licensed under this chapter as a cultivator, dispensary, processor, producer, or safety compliance facility;
- (3) "Cultivator" means an entity licensed as such under KRS 218B.080, 218B.085, and 218B.090;
- (4) "Dispensary" means an entity licensed as such under KRS 218B.080, 218B.085, and 218B.090;
- (5) "Medicinal cannabis" means
 - (a) marijuana as defined in KRS 218A.010 when cultivated, harvested, processed, produced, transported, dispensed, distributed, sold, possessed, or used in accordance with this chapter;
 - (b) includes medicinal cannabis products and raw plant material; and
 - (c) Does not include industrial hemp or industrial hemp products as defined in KRS 260.850;
- (6) "Processor" means an entity licensed as such under KRS 218B.080, 218B.085, and 218B.090;
- "Producer" means an entity licensed as such under KRS 218B.080, 218B.085, and 218B.090; (8) "Safety compliance facility" means an entity licensed as such under KRS 218B.080, 218B.085, and 218B.090;

Section 2

Cannabis Businesses Authorized (1) All cannabis businesses are hereby authorized to operate in the city limits of Springfield.

(2) "Cannabis business" means any entity licensed under Chapter 218B of the Kentucky Revised Statutes as a cultivator, dispensary, processor, producer, or safety compliance facility. Section 3

This Ordinance shall be effective immediately upon its enactment by the City of Springfield following second reading and publication in accordance with the requirements of applicable Kentucky law.
