**County park given publicity**

A salute to autumn is the theme of the attractively illustrated fall issue of "In Kentucky," the magazine published quarterly by the division of Publicity, Kentucky Department of conservation. Among the featured articles appearing in the issue, which came off the press this week, are "An outline of the State's Present and Future Highway Program," by H. St. G.T. Carmichael, Jr.; "Mettle of Kentuckians Tested at Blue Licks," by Robert A. Blair; "Rich Green Gold Harvest From Wastelands," by Harrod B. Newland; "Kentucky Lake," by James J. Gilpin; "Kentucky Dollars Going on Missions of Mercy," by Kirtley Scott; "Georgetown College, First Baptist School West of the Alleghenies," "Flying Florence Nightengales Trained at Bowman Field," "Lincoln Homestead Park in Washington County," "Daughter of Governor Launches an LST," "Mill Springs Mill," and "Mammoth Cave."

On the cover is a photograph, in color, of a Kentucky hemp scene made by B.R. Hare of Versailles. Poems by Adele E. Show and Sue Wyatt Semple are given prominent positions in this issue. Forty-six pictures, the majority of them Kentucky scenes, are used to illustrate articles.

Approximately 10,000 copies of "In Kentucky" are sent to army camps, air and naval bases, army and naval hospitals, U.S.O. clubs and canteens in this country and the four corners of the globe.

**County man killed in Sunday night accident**

Charlie B. Ross, 37, was killed instantly about 12 o'clock Sunday night when his truck skidded, left the highway, climbed an embankment, skidded sidwise across a ditch and upset at the roadside.

Rose was thrown from the truck and evidently landed on his

head, which was badly crushed by the impact.

The accident occurred on Lawrenceburg Road, two miles North of Willisburg, near the R.C. Riley home.

Riding with Mr. Ross were Mrs. Birchie Shewmaker, who suffered a serious injury in her right side, a minor head injury and bruises and cuts, and Herbert Tingle, who escaped with minor cuts and bruises. Mrs. Shewmaker was taken to Mary Immaculate Hospital for treatment. The truck was badly damaged.

Mr. Ross was prepared at the Hale & Polin mortuary here and was taken to the family home Monday afternoon to await burial.

**Woman killed, 2 are injured in Boyle wreck**

According to a report from the Sunday Kentucky Advocate, Danville, Mrs. Luch Francis Goins, 58, Lancaster, was fatally injured at 1:55 Saturday afternoon, Oct. 24, 1964, her son, Elmer Goins,

Lexington, driver of the Goins car, suffered a fractured arm and other injuries, and his sister, Miss Brenda Goins, Lancaster, had a shoulder injury, when their Pontiac auto clipped the left rear of a car they were passing and crashed into the left side of Clarks Run Bridge on Ky. 52 near Danville. Mrs. Goins died as she was being taken to the emergency room at McDowell Hospital in Danville.

Trooper Evans said the river of the second car was Jerry A. Chatham, 16, of Route 1 Willisburg, with his passengers, Larry Perkins, 20, Route 2 Summerdale; Dellie Charlene Barnett, 10, Routh 3-A, Springfield; Pat Derringer, 17, Route 1 Mackville; Fredia Gillis, 17, Star Route, Springfield, and Brenda Boblitt, 17, Route 1, Willisburg. They had also been traveling toward Danville and all were wearing cheerleaders' uniforms, the state trooper said. Their car was only slightly scratched on the left rear bumper and fender.

Trooper Evans said Goins apparently attempted to pass Cheatham's car and, as Goins came out from behind the other vehicle, he clipped the left rear corner of the Cheatham automobile. This evidently threw Goins' automobile out

of control and it then traveled to the left side of the Lancaster Road and smashed into the Clark's Run Bridge, abutment where it was halted.

Goins' car was completely demolished.

The Springfield Planning Commission will hold a public hearing on November 6th at 6:00 p.m. at Springfield City Hall, 127 West Main Street, Springfield, KY 40069. This public hearing notice is required by KRS 100.211. The purpose of this public hearing is to accept public comments on the amendment of the text of zoning regulations. **FAIR HOUSING LAWS**

The Federal Fair Housing Act prohibits discrimination in the sale, rental, leasing and financing of housing, as well as discriminatory advertising, on the basis of RACE, SEX, COLOR, RELIGION, NATIONAL ORIGIN, MENTAL or PHYSICAL HANDICAP, or FAMILIAL STATUS.

"These laws cover any potential or actual sale, lease, rental, eviction, price, terms, privileges or any service in relation of the sale of or use of housing. They not only prohibit advertisements that clearly restrict access to housing based on the protected categories, but also prohibit advertisements that indicate a preference for or against a person based on a protected category. In particular circumstances, use of colloquialisms, symbols or directions to real estate for sale or rent may indicate a discriminatory preference."

"It is the intent and goal of this newspaper to have each advertiser who wishes to place a covered advertisement in the newspaper comply with the Fair Housing laws. Any advertisement that is perceived to contain language contrary to these laws will be rejected or changed to remove the offending reference. There may be situations where it is not clear whether particular language is objectionable. Such advertisements should be referred to a supervisor for consideration and determination. Under certain circumstances, advertisers may claim that because of the nature of the housing being advertised, they are not subject to the Fair Housing laws. Such claims are irrelevant for purposes of considering advertisements for publication in this newspaper. Every housing advertisement published in this newspaper is subject to the Fair Housing laws."
