This notice shall satisfy a procedural requirement for the activities to be undertaken by the Clark County Fiscal Court.

**TO ALL INTERESTED AGENCIES, GROUPS, AND PERSONS:**  
 On or about December 19, the Clark County Fiscal Court will submit a Finding of No Significant Impact to the Department for Local Government for environmental clearance of the Community Development Block Grant (CDBG) under Title 1 of the Housing and Community Development Act of 1974 (PL 93-383) and to undertake the proposed project if approved for funding:

**Project Name:** Clark County US60/Rockwell Rd Sewer Project  
**Project Purpose:** Community Development Block Grant (CDBG) and Appalachian Regional Commission Grant (ARC)  
 The Clark County Sanitation District's Sewer Improvement Project will involve the installation of 13,000 linear feet (LF) of 6-inch force main, the construction of a new pump station, and the decommissioning of the existing Package Wastewater Treatment Plant. The project will begin at Yorktowne Mobile Home Park and extend along Rockwell Road to Gawthrop Drive, providing much-needed sewer service to approximately 280 households and 5 businesses, with capacity for future growth.

This project is one of two construction contracts that will connect the area to the Western Municipal Utilities (WMU) Wastewater Treatment Plant (WWTP) at Van Meter Road. Construction for this project will begin once the notice of award is issued for the installation of a gravity sewer line from Gawthrop Drive to the WWTP. The two projects will be constructed concurrently, enabling the seamless transfer of wastewater from Yorktowne Mobile Home Park to the WWTP, improving sanitation services for the area and supporting future development.

Project will take place within Clark County extending the Clark County Sanitation District and Winchester Municipal Utilities service areas to the Yorktowne, with potential for future connections.

### FINDING OF NO SIGNIFICANT IMPACT

The Clark County Fiscal Court has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) (PL-91-190) is not required. An Environmental Review Record (ERR) respecting the within project has been made by the Clark County Fiscal Court which documents the environmental review of the project and more fully sets forth the reasons why such a statement is not required. This Environmental Review Record is on file at the Clark County Courthouse, 34 S Main Street Winchester, KY 40391 and is available for public examination and copying, upon request, at the Clark County Courthouse between the hours of 8 A.M. and 4:30 P.M. No further environmental review of such project is proposed to be conducted.

### PUBLIC COMMENTS

All interested agencies, groups, and persons disagreeing with the ERR decision are invited to submit written comments for consideration by the Chairman of Clark County Sanitation District to the Clark County Courthouse. Such written comments should be received at (34 S Main Street, Winchester KY, attn: Office of the Clark County Judge Executive) on or before December 19, 2024. All such comments so received will be considered prior to authorizing the submission of the Finding of No Significant Impact or taking any administrative action on the within project prior to the date specified on the proceeding sentence.

### ENVIRONMENTAL CERTIFICATION

The Clark County Fiscal Court will undertake the project described above with CDBG and ARC funds from the Department for Local Government (DLG) under Title I of the Housing and Community Development Act of 1974.

The Clark County Fiscal Court is certifying to the state that the Fiscal Court and Les Yates, in his official capacity as Judge Executive, consent to accept the jurisdiction of the federal courts if an action is brought to enforce responsibilities in relation to environmental reviews, decision making, and action; and that these responsibilities have been satisfied. The legal effect of the certification is that upon its approval the Clark County Fiscal Court may use the CDBG Grant funds and the state and HUD will have satisfied their responsibilities under the National Environmental Policy Act of 1969 and related laws and authorities.
