
## Obituaries

## HONORING PFC WINFORD ARNETT

WHEREAS, the Magoffin County Fiscal Court wishes to recognize the contributions and sacrifices made by Private First Class Winford Arnett to his country; and

WHEREAS, Winford Arnett was born December 12, 1922 in Sublett located in Magoffin County, Kentucky.

WHEREAS, Winford Arnett enlisted in the United States Army at age 17 in the early part of 1940. Private First Class Winford Arnett attended his training at Fort Bragg, North Carolina. He went to Fort Guber, Oklahoma, to continue his training. Private First Class Arnett was assigned to Fort Sam in Houston, Texas to complete additional training for his oversea tour. After his training at Fort Sam, he was shipped overseas in the later part of 1943 and assigned to the 5th Anny in South Africa. Private First Class Arnett participated in many battles in Africa to push the Germans back and break the lines. After serving in South Africa, his unit went to Italy to be part of the joint mission of the 5th and 8th Anny, and allied forces broke the German lines which enabled the American forces to move towards Rome. During a fierce battle on May 21, 1944, Private First Class Winford Arnett was wounded and spent approximately a month in the hospital. After his convalesce, Private First Class Arnett went back into action. On July 12, 1944, in a fierce battle. Private First Class Winford Arnett was killed in action.

WHEREAS, Private First Class Winford Arnett's heroic actions was awarded the Purple Heart, and many other commendations.

WHEREAS, Private First Class Winford Arnett did not make it home to talk to loved ones and friends about his experiences of the war. Private First Class Amett's' body was brought home in 1948.

Private First Class Winford Arnett now lays in peaceful sleep in the hands of the Supreme Commander at the Ray Arnett Family Cemetery.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that S Arnett Branch (CR-1217), from mile point 0.00 to mile point 0.859, be forever known as Private First Class Winford Arnett Memorial Road.
