Due to the proposed project on the Mountain Parkway corridor to extend the four lane Mountain Parkway from US 460 to the Magoffin/Floyd County line, officially designated as Magoffin County 10-0169.00; the Commonwealth of Kentucky, Transportation Cabinet, Department of Highways deems it necessary to remove and relocate the graves in what is known as the Brown Cemetery, located near the intersection of US 460 and KY 114 in Salyersville, KY. NOTICE OF BOND RELEASE

In accordance with KRS 350.093, notice is hereby given that Liberty Management, LLC., P. O. Box 100, Ary, Kentucky 41712-0100 has applied for a Phase I Bond Release on Increment Numbers 18 and 21 of Permit Number 836-0483, which was last issued on February 14, 2023. The application covers an area of approximately 606.47 acres and is located approximately 1.00 mile southeast of Brainard in Floyd and Magoffin Counties.

The permit is located approximately 0.75 miles southwest of Ky Route 114's junction with Prater Branch Road and located approximately 0.92 southwest of Middle Creek. The operation is located on the Ivyton U.S.G.S. 7 ½ minute quadrangle.

The bond now in effect for Increment Number 18 is a Surety Bond in the amount of one hundred seventeen thousand nine hundred dollars (\$117,900) of which sixty percent (60%) of the bond is being requested for release. The bond now in effect for Increment Number 21 is a Surety Bond in the amount of seventy-seven thousand dollars (\$77,000) of which sixty percent (60%) of the bond is being requested for release.

Reclamation work performed on Permit Number 836-0483 include: backfilling, final grading, seeding and mulching was completed in spring of 2009.

Written comments, objections, and requests for a public hearing or informal conference must be filed with the Director, Division of Field Services, 300 Sower Boulevard, Second Floor, Frankfort, Kentucky 40601-6571 by Friday, December 20, 2024.

A public hearing on the application has been scheduled for Monday, December 23, 2024 at 10:00 a. m. at the Department for Natural Resource's Hazard Regional Office, 556 Village Lane, P.O. Box 851, Hazard, Kentucky 41702-0851. The hearing will be canceled if no request for a hearing or informal conference is received by Friday, December 20, 2024.
