A Morehead man, who allegedly ransacked his mother's home last November, and who was named in two separate indictments by members of a February 3, 2023 Rowan County Grand Jury, has entered guilty pleas to burglary, assault, and other criminal charges..

Steven Barker, 39, of Morehead, was indicted last February on charges of burglary, 2nd degree; disorderly conduct, 1st degree; assault, 3rd degree-police officer and being a persistent felony offender, 2nd degree.

According to the indictment, which was issued following the testimony of Morehead Police Officer, Phillip Blackburn; and

on November 27, 2022, Morehead Police Department received a call from a resident on Walton Street, stating her son was destroying her home and would not leave.

After his arrest, Barker allegedly continued screaming, shouting that he was, "Going to rape and kill everyone."

Neighbors, including children, were witness to these events according to court documents.

When transported to County Detention Center the detention center, Barker allegedly spit other court documents, through the cruiser cage on Officer, M. Salley.

Barker has prior felony convictions of theft, and other charges in Rowan Circuit Court.

According to that inwas issued following

the testimony of Officer Blackburn, the alleged crimes were committed in Rowan County oon May 18, 2022, when Barker allegedly "jumped onto the back of a 2013 Chevy cruise owned by Angela Black causing \$1,757 worth of damage, "punched Elizabeth Betrtam in the face and neck with his fists; "punched Emily Myers in the back of the head," and has prior felony conviction.

In exchange for his guilty pleas, Commonwealth Attorney, Ashton McKenzie recommends that Barker be sentenced to six years each for the two criminal cases for a total of six years in prison.

All persons are to be presumed innocent until proven guilty or pleading guilty.





MOREHEAD UTILITY PLANT BOARD SPRING FLUSHING SCHEOULE

In accordance with the Kentucky Adminiskative Regulations, 401 KAR 8:020 SECTION 2, 13a.

"To protect public health, a distribution system may be thoroughly flushed at least twice a year, usually in the spring and fall. The purpose of systematic flushing is to reduce turbidity created from the scouring of accumulated sediment within the water lines."

The Morehead Utility Plant Board (MUPB) will be conducting annual spring flushing of distribution lines the weeks of May 20th through May 24th and May 27th through May 31st. Hydrants throughout the system will be flushed to remove normal sediments that can collect over time. Please check for discolored water before doing laundry, washing dishes or other uses. If your water is discolored, run your faucet until it clears. If you need further information, please contact the MUPB at 606-784-5538.
