# Former Marine fighter pilot Amy McGrath launches a second U.S. Senate bid

Former Marine fighter pilot Amy McGrath has launched a campaign for Kentucky's open U.S. Senate seat, her second U.S. Senate bid after losing to longtime Republican incumbent Sen. Mitch McConnell in 2020.

McGrath in a social media post Monday morning featured a video of her walking up to a lone chair while saying, "This isn't just a chair. It's an open seat." McConnell, 83, the Senate's longest-ever party leader, set off what promises to be a fierce fight for his seat when he announced in February that he would not seek an eighth term. McGrath is joining

Democrats already vying for the open U.S. Senate seat and at least three Republicans. McGrath wrote in her

social media post that

"democracy was under siege" and "cowards in Washington are bowing to Donald Trump." "Kentuckians deserve

someone battle-tested and ready to fight for them on day one. I've spent my life stepping up when the mission was tough and the stakes were high, first as a Marine and now for Kentucky. I'm ready to complete the mission," McGrath wrote in her post launching the campaign.

McGrath said in her video that Kentucky's open U.S. Senate seat "will decide the balance of power in the Senate." The veteran fighter

pilot spent more than \$90 million as the Democratic U.S. Senate candidate challenging McConnell in 2020, losing by over 400,000 votes. She previously ran for Congress in 2018 to represent Kentucky's 6th Congressional District covering central Kentucky, losing to

Republican U.S. Rep. last month reporting Andy Barr by 3 percentage points in a significantly closer Barr is now among

the candidates in the Republican primary also seeking the U.S. Senate seat, along with former Kentucky **Attorney General Daniel** Cameron and Lexington businessman Morris.

In response to a Lexington Herald-Leader article published

that McGrath was considering launching a campaign, Barr wrote in a post on X: "Bring it on, Amy. This will be fun. I beat you once, and I'll beat you again." Other Democrats who

have announced for the Senate seat are former Secret Service agent Logan Forsythe, former CIA officer Joel Willett and Kentucky House Democratic Pamela Leader Stevenson.

The funding will repair, replace or preserve bridges to improve safety, extend their lifespan, remove lengthy detours and maintain important community links for Kentuckians.

Kentucky's bridges don't just connect roads, they connect our families to their jobs, schools communities," Beshear said. "While construction may seem like a hassle, these projects will mean safer travel, fewer traffic delays, and more potholes getting fixed. These are good things for Kentuckians."

Awards will be issued to the following recipients: Barren County Fiscal Court, Calloway County Fiscal Court, City of Georgetown, City of Winchester, City of Wurtland, Crittenden County Fiscal Court, Graves County Fiscal Court, Laurel County Fiscal Court, Letcher County Fiscal Court, Livingston County Fiscal Court, Marion County Fiscal Court, Mason County Fiscal Court, McCracken County Fiscal Court, Trigg County Fiscal Court, Union County Fiscal Court and Washington

This fourth round of awards funds 12 bridge replacements and five bridges that will be repaired or preserved to extend the life of existing structures. All 17 bridges are currently closed or posted with

weight restrictions. Kentucky Transportation Cabinet (KYTC) engineers reviewed and validated each project to ensure the most effective solution. "With these awards,

we're addressing the structures that most urgently need attention, so Kentuckians can travel safely and with confidence, **Transportation Secretary** Jim Gray. "Replacing closed bridges and restoring access for school buses and large vehicles makes a big difference not only in time savings but in the quality of life for residents.'

Since the first round of funding announced in 2025, \$32.6 million has been awarded local governments to address bridges that are closed, have posted weight restrictions or are in need of repairs.

# PSC approves adjusted rate increase for Duke Energy

The Kentucky Public Service Commission (PSC) announced Friday that it has issued an Order in Duke Energy Kentucky, Inc.'s filing for a general adjustment of rates and other general relief.

On Dec. 2, 2024, Duke requested authorization to increase its annual electric base rate revenue by \$70,008,476 or 15.41 percent from its current rates. Duke Kentucky's last adjustment of its electric rates was granted

In this latest order, the PSC approved rates that will produce an annual increase in revenues of \$43,692,476 or 9.61 percent. The energy charge for residential customers will increase from \$0.111639 per kWh to

\$0.122399 per kWh with a monthly customer charge of \$14.75 per month. An average residential customer using about 1,000 kWh of energy will receive an increase of \$12.51, or 10.04 percent, increasing the average bill from \$124.64 to \$137.15 per The order

approved new language regarding the terms and conditions for commercial time-of-day rates. The language sets a new minimum demand provision for new loads of 40 MW to receive the commercial rate. The new language will ensure that the cost of providing power to future high demand customers will not be shifted to existing customers under Duke Kentucky's commercial time-of-day tariff.
