Lexington warns of whooping cough outbreak

Public health officials in Lexington are warning of an outbreak of pertussis, commonly known as whooping cough, with nearly a dozen cases in Fayette County in just over a month.

The Lexington-Fayette County Health Department has confirmed 11 cases of pertussis since Oct. 3, with the majority reported since Oct. 24. Ten of the cases involve school-age children, and one case is a 1-year-old child. All individuals were up to date on their vaccinations.

Pertussis is a highly contagious respiratory illness spread through coughing and sneezing, and it can be particularly severe for infants and those with chronic conditions.

Symptoms can begin like a common cold, including a runny nose, sneezing, lowgrade fever and a nagging cough that resembles an allergy, but persists. After one to two weeks, the cough may worsen, becoming intense and uncontrollable, sometimes accompanied by a "whooping" sound when gasping for air, vomiting or exhaustion.

Caregivers should check for these symptoms in themselves and children and seek testing if pertussis is suspected.

"Vaccines are one of the major achievements of modern medicine, helping

Crystal Miller, commissioner of health for LFCHD. "Pertussis (aka whooping cough) is one of those vaccine preventable diseases. We encourage families to get their children vaccinated and stay up to date on vaccines."

The pertussis vaccine is routine and required for school-age children, with a Tdap booster recommended for those aged 11 and older. Immunity can wane over time, making boosters critical for older children and adults. Those who have never

received the Tdap vaccine should contact their primary care provider or local health department to check avail-Children with pertussis

symptoms should stay home from school and visit a healthcare provider for evaluation, even if vaccinated. Those diagnosed with probable or confirmed pertussis must remain out of school until completing antibiotic treatment.

If someone in your household has pertussis, it's recommended that other members of the household take a preventive antibiotic, called postexposure prophylaxis (PEP), to help stop the infection from spreading.

Central Kentucky caregivers are encouraged to ensure all household members are up to date on vaccinations, including boosters, and to be vigilant for pertussis symptoms.

State revenues slide o.5 percent in October

State Budget Director John Hicks reported Monday that October's General Fund receipts declined 0.5 percent compared to last year, as revenues for the month were \$1,181.6 million compared to \$1,187.9 million collected in October 2024. The official General Fund

revenue estimate for FY26 calls for revenue to decline 2.3 percent compared to FY25 actual receipts. Based on receipts through the first four months of FY26, General Fund revenues can decline 2.2 percent for the remainder of the fiscal year and still meet the official estimate.

"Sales tax collections continue to improve, growing 14.5

percent in the month of October and 6.5 percent through the first four months of FY26," Hicks said. "The individual income tax also remains strong. Withholding collections increased 3.0 percent in October and 6.4 percent so far this fiscal year. Major business taxes declined by \$118.4 million. The large drop in major business taxes was primarily attributable to the nonrecurring revenues of over \$80.0 million received in October of 2024."

Among other accounts:

•Property tax revenues rose 1.3 percent and are down 12.7 percent year-to-date.

 Cigarette tax receipts rose 14.3 percent and are down 3.6 percent for the first four months of the fiscal year.

 Coal severance tax receipts were \$5.3 million, 54.8 percent more than last year. Year-todate receipts have declined 3.6

 Lottery revenues grew 2.3 percent to \$40.9 million in October and have increased 3.2 percent for the year.

Road Fund revenues grew 4.9 percent in October, with year-to-date collections up 1.3 percent compared to the previous year.

Motor fuels taxes rose 0.8 percent, down 2.4 percent for the year. Motor vehicle usage tax collections grew 2.5 percent. License and privilege revenues rose 24.2 percent in October and are up 11.8 percent for the year. Nontax receipts rose 34.4 percent for the month, down 12.1 percent for the year.
