ORDINANCE ADOPTING THE ANNUAL CITY BUDGET

AN ORDINANCE ADOPTING THE CITY OF MORGANTOWN, KENTUCKY ANNUAL OPERATING BUDGET FOR FISCAL YEAR BEGINNING JULY 1, 2025 AND ENDING JUNE 30, 2026, BY ESTIMATING REVENUES AND APPROPRIATING FUNDS FOR THE OPERATION OF CITY GOVERNMENT

WHEREAS, an Annual Operating Budget proposal has been prepared and delivered to the City Council of the City of Morgantown, Kentucky; and, WHEREAS, the City Council has reviewed and discussed the proposed Annual Operating Budget and desires to adopt it for Fiscal Year 2026.

NOW THEREFORE, BE IT ORDAINED by the City of Morgantown, Kentucky as follows: 1. The Annual Operating Budget for the Fiscal Year beginning July 1, 2025 and ending June 30, 2026, including all sources of estimated revenues and appropriations for all City

- funds as set forth in Exhibit 1 attached hereto is hereby adopted. 2. All encumbrances outstanding on June 30, 2025 for goods not yet provided or services not yet rendered are hereby re-appropriated in conformance with generally accepted
- accounting principles for the Fiscal Year beginning July 1, 2025 and ending June 30, 2026. 3. The balance of all capital construction, renovation, improvement projects and grants currently approved and/or nearing completion are hereby approved for re-appropriation and carry over for Fiscal Year beginning July 1, 2025 and ending June 30, 2026.
- 4. The provisions of this Ordinance are hereby declared to be severable, and if any section, phrase, or provision shall for any reason be declared invalid, such declaration of invalidity shall not affect the validity of the remainder of this Ordinance.
- 5. All prior Municipal Orders or Ordinances or parts of any Municipal Orders or Ordinances in conflict herewith are hereby repealed.
- 6. This Ordinance is adopted pursuant to KRS 83A.060 in that it was introduced on May 8, 2025 and given final reading on June 12, 202 and said Ordinance shall be in full force

and effect upon signature, recordation and publication in summary pursuant to KRS Chapter 424.

An Air India plane crashed last Thursday, slamming into B.J. Medical School in Ahmedabad, India, sending a fiery explosion into the air-the same school two doctors in Glasgow have ties to.

Flight AI171 left shortly before it crashed at 13:39 local time, just 0.9 miles from where the plane took off from the runway at Sardar Vallabhbhai Patel International Airport. Transmitted data in the final moments of the plane's flight noted it was was approximately 625 feet in the air.

The plane crashed into the medical school just moments after take-off, carrying 230 passengers and 12 crew members. ABC News reports that hospital officials have stated five medical students inside B.J. medical college and hospital, where the airplane crashed, also died. Many others were injured.

The total number of people who perished on the ground hasn't been confirmed but a couple of reports note five to eight people as of Friday afternoon. Drs. Bharat and Bharati

Mody, two local, well-known medical practitioners, completed their residencies at B.J. Medical School. Dr. Bharati Mody attended the medical school. "She went to the medical

school and has eaten inside the same cafeteria the plane crashed on top of," Dr. Bharat Mody said of his wife, Bharati.
