The Butler County Board of Education will hold a public hearing at The Butler County Early Childhood Center on October 1, 2025 at 5:30 PM to hear public comments regarding a proposed general fund tax levy of 48.4 cents on real property and 48.4 cents on personal property.

The General Fund tax levied in fiscal year 2025 was 41.6 cents on real property and 41.6 cents on personal property and produced revenue of \$2,590,773.61. The proposed General Fund tax rate of 48.4 cents on real property and 48.4 cents on personal property is expected to produce \$3,400,252.54. Of this amount, \$682,317.86 is from new and personal property. The compensating tax for fiscal year 2026 is 40.4 cents on real property and 40.4 cents on personal property and is expected to produce \$2,838,227.33.

The areas to which revenue of \$809,478.93 above 2025 revenue is to be allocated will be Cost of Collections, \$32,379.16; instruction, \$334,504.92; and building fund


